NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Workshop and Hearing for the Adoption, Amendment or Repeal of Regulations Of The State of Nevada Contractors' Board

The State of Nevada Contractors' Board ("Board") will hold a workshop and public hearing at the Board's Reno Office located at 9670 Gateway Drive, Reno, Nevada 89521 on Monday, August 4, 2003 and videoconferenced to the Board's Henderson Office located at 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074. The workshop will begin at 3:30 p.m. and the hearing will commence immediately following the workshop. The purpose of the workshop and hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations that pertain to Chapter 624 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.060 and 233B.0603:

1. The need for and purpose of the proposed regulation or amendment.

The purpose of the proposed regulation is to amend Chapter 624 of the Nevada Administrative Code to provide a more streamlined license classification system. The proposed regulation would repeal the current C 32; C 34 and C 35 license classifications and reclassify those licensees as a defined specialty classification; modify the language of the C 5 classification by eliminating the subcategories and combining all work to be performed under the C 5 classification.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed or a description of the subjects and issues involved.

The proposed regulation repeals the current C 32; C 34 and C 35 license classifications; modifies the existing C 5 classification by eliminating the subclassifications and combining all work authorized under the subclassifications to be performed under the C 5 classification. A copy of the proposed regulation may be obtained by writing to the Board's offices at 9670 Gateway Drive, Reno, Nevada 89521.

- 3. The estimated economic effect of this proposed regulation on the business which it is to regulate and on the public.
 - (a) Adverse and beneficial effects.

There should be a minimal economic effect.

(b) Both immediate and long-term effects.

This regulation simply streamlines current language therefore, there should be no immediate or long-term effects.

- 4. The estimated cost to the Agency for enforcement of the proposed regulation.
 - There will be minimal cost to the agency.
- 5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary.

The proposed regulation does not overlap or duplicate any regulation of other state or local governmental entities.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law.

Does not apply.

- 7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.
 Does not apply.
- 8. Whether proposed regulation establishes a new fee or increases an existing fee. Does not apply.

Written submissions must be received by the Board on or before Wednesday, July 30, 2003. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board may proceed immediately to act upon any written submissions.

A copy of this notice and the regulations to be adopted, amended or repealed will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notices and the regulation to be adopted will be available at the State Contractors' Board, 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074 and 9670 Gateway Drive, Suite 100, Reno, Nevada 89521. In all counties in which an office of the Board is not maintained, a copy of this notice and the text of the proposed regulation will also be available for public inspection and copying at the main public library during business hours. This notice and the text of the proposed regulation will be available in the State of Nevada Register of Administrative Regulations which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the Board, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

PROPOSED REGULATION OF THE NEVADA STATE CONTRACTORS BOARD

June 4, 2003

AUTHORITY: NRS 624.215, NRS 624.220

NAC 624.230 Classification C-5: Concrete contracting. [subclassifications.]

- [1.] The board will grant to qualified applicants a license in the specialty of concrete contracting. The board designates such a license as a "classification C-5" license. A person who holds a classification C-5 license may perform *work in the following areas:*
- Pouring, placing, finishing and installing concrete.
- Preparing the surface, placing reinforcement steel and other embedded items essential to or comprising an integral part of the concrete or concrete construction.
- · Constructing and assembling forms, molds, slipforms, and pans.
- Applying concrete sealants and waterproofing products.
- Sawing, cutting, drilling and coring of concrete and asphaltic paving materials.

[any of the work authorized for the subclassifications of the classification C-5 license.]

- [2, The subclassifications of the classification C-5 license and the work authorized for persons licensed in the respective subclassifications are:
 - (a) CONCRETE POURING (subclassification C-5a): To:
 - (1) Prepare the surface, place reinforcement steel, form;
 - (2) Proportion and mix aggregates to make concrete;
 - (3) Pour, place, finish and install concrete; and
 - (4) Place screeds for pavement and concrete.
- (b) CONCRETE CUTTING (subclassification C-5b): The sawing, cutting, drilling and coring of conrete and asphaltic paving material]

[NAC 624.490 Classification C-32: Setting refractories. The board will grant to qualified applicants a license in the specialty of setting refractories. The board designates such a license as a "classification C-32" license. A person who holds a classification C-32 license may set refractories and firebrick (with or without the use of cement or mortar) and may prepare the surface for the setting.]

[NAC 624.510 Classification C-34: Installing bowling alleys. The board will grant to qualified applicants a license in the specialty of installing bowling alleys. The board designates such a license as a "classification C-34" license. A person who holds a

classification C-34 license may install, lay, finish and repair bowling alleys and the equipment used to handle pins and balls, including all equipment and controls required to install automatic scoring systems. This license does not authorize the holder to erect any building or other structure.]

[NAC 624.520 Classification C-35: Installing vaults and safes. The board will grant to qualified applicants a license in the specialty of installing vaults and safes. The board designates such a license as a "classification C-35 license. A person who holds a classification C-35 license may install vaults, safes and depositories in structures and may erect concrete, masonry and steel vaults, including the installation of automatic tellers for banks.]
