NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Workshop and Hearing for the Adoption, Amendment or Repeal of Regulations Of The State of Nevada Contractors' Board

The State of Nevada Contractors' Board ("Board") will hold a workshop and public hearing on Friday, May 21, 2004. The workshop will begin at 10:00 a.m. and the hearing will commence immediately following the workshop. The workshop and hearing will be video-conferenced between the Board's Henderson Office located at 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074 and the Reno Office located at 9670 Gateway Drive, Reno, Nevada 89521. The purpose of the workshop and hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations that pertain to Chapter 624 of the Nevada Administrative Code.

The following information is provided pursuant to the requirements of NRS 233B.060 and 233B.0603:

- 1. The need for and purpose of the proposed regulation or amendment.
 - The purpose of the proposed regulation is to amend Chapter 624 of the Nevada Administrative Code to streamline the C-8 (Glass and glazing) and C-14 (Steel reinforcing and erection) classification.
- 2. Either the terms or the substance of the regulations to be adopted, amended or repealed or a description of the subjects and issues involved.

The proposed regulation eliminates several of the current subclassifications and streamlines and combines the work performed under a C-8 (Glass and glazing) classification and streamlines the C-14 (Steel reinforcing and erection) classification. - 3. The estimated economic effect of this proposed regulation on the business which it is to regulate and on the public.
 - (a) Adverse and beneficial effects.

The adoption of this regulation should be beneficial to the industry since it will clearly specify the type of license required to perform specific work.

(b) Both immediate and long-term effects.

The immediate and long term effect of implementing a classification change should provide for a more efficient manner in which to classify specific types of work into the correct subclassification.

- 4. The estimated cost to the Agency for enforcement of the proposed regulation.
 - There will be minimal cost to the agency since the implementation of the proposed regulation will provide clear descriptions of the type of work that can be performed with specific classifications.
- 5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary.

The proposed regulation does not overlap or duplicate any regulation of other state or local governmental entities.

6. If the regulation is required pursuant to federal law, a citation and description of the federal law.

- 7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.

- 8. Whether proposed regulation establishes a new fee or increases an existing fee. Does no apply.

Written submissions must be received by the Board on or before Tuesday, May 18, 2004. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board may proceed immediately to act upon any written submissions.

A copy of this notice and the regulations to be adopted, amended or repealed will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notices and the regulation to be adopted will be available at the State Contractors' Board, 2310 Corporate Circle, Suite 200, Henderson, Nevada 89074 and 9670 Gateway Drive, Suite 100, Reno, Nevada 89521. In all counties in which an office of the Board is not maintained, a copy of this notice and the text of the proposed regulation will also be available for public inspection and copying at the main public library during business hours. This notice and the text of the proposed regulation will be available in the State of Nevada Register of Administrative Regulations which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the Board, if requested to do so by an interested person, either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

PROPOSED REGULATION OF THE STATE CONTRACTORS BOARD

EXPLANATION – Matter in italics is new; matter in brackets [] is material to be omitted.

NAC 624.260 Classification C-8: Glass and glazing contracting; subclassifications. (NRS 624.220).

- 1. The board will grant to qualified applicants a license in the specialty of glass and glazing contracting. The board designates such a license as a "classification C-8" license. A person who holds a classification C-8 license may install, repair and replace glass and glass products, glass holding members, frames and hardware, including the glazing of frames, panels, sash and doors; window walls and store fronts, including the installation of lightweight metal; automatic and revolving doors; and enclosures for showers, tubs and toilet partitions. [perform any of the work authorized for the subclassifications of the classification C-8 license.]
- [2. The subclassifications of a license designated classification C-8 and the work authorized for persons licensed in the respective subclassifications are:
- (a) GLAZING (subclassification C-8a): The selecting, cutting, assembling and installing of types of glass and the glazing of frames, panels, sash and doors, in such a manner that an acceptable structure of frames, glazed panels, sash or doors can be installed.
- (b) WINDOW WALL (subclassification C-8b): The installation of such materials as are generally accepted by contractors for use as window walls, including the installation of lightweight metals for decorative treatments when the metals are installed with clips or a similar method of attachment, but not the fabrication and installation of any frame, panel, sash, door or load bearing wall or partition in any structure.
- (c) STORE FRONTS (subclassification C-8c): The work described in paragraph (b), but limited to the construction of window walls in the front of stores, and the installation of lightweight metals to a height not exceeding 25 feet from the threshold of the entrance on the ground floor of the store.
- (d) ENCLOSURES FOR SHOWERS AND TUBS AND TOILET PARTITIONS (subclassification C-8d): The installation of enclosures for showers, tubs and toilet partitions.
 - (e) AUTOMATIC DOORS (subclassification C-8e): The fabrication and installation of automatic and revolving doors, including all appurtenances.]

NAC 624.310 Classification C-14: Steel reinforcing and erection; subclassifications.

- 1. The board will grant to qualified applicants a license in the specialty of steel reinforcing and erection. The board designates such a license as a "classification C-14" license. A person who holds a classification C-14 license may perform any of the work authorized for the subclassifications of the classification C-14 license.
- 2. The subclassifications of the classification C-14 license and the work authorized for persons licensed in the respective subclassifications are:
- (a) REINFORCING STEEL (subclassification C-14a): The fabrication, placement, [and] ty[p]ing of steel reinforcing bars (rods), and post tensioning [used] to reinforce concrete buildings and structures.
- (b) STRUCTURAL STEEL (subclassification C-14b): The fabrication and erection of structural steel shapes and plates used as structural members, or tanks, including any connected riveting, welding and rigging.
- (c) ORNAMENTAL –METAL (subclassification C-14c): The assembling, casting, cutting, shaping, stamping, forging, fabricating and installing of [sheet, rolled or cast brass, bronze, copper, cast iron, wrought iron, stainless steel and any other] metals [or combination of metals customarily used by contractors] for the architectural treatment, ornamental decoration or security of structures, but does not include the work authorized by a sheet metal classification.[C-13 license.]
- (d) CURTAIN WALL (subclassification C-14d): The installation of such materials as are generally accepted by contractors for use as curtain wall materials.
- (e) METAL DOORS AND [FRAMES] WINDOWS (subclassification C-14e): The installation of metal doors and frames, and metal windows and frames.
- [(f) METAL WINDOWS AND FRAMES (subclassification C-14f): The installation of metal windows and frames.]
- [g] (f) STORE FRONTS (subclassification C-14f): The construction of window walls in the fronts of stores and the installation of lightweight metals to a height not exceeding 25 feet from the threshold of the entrance on the ground floor of the store.
- [h](g) PREFABRICATED STEEL STRUCTURES (subclassification C-14g): The construction of structures made of prefabricated steel for the support, shelter or enclosure of persons, animals or other chattels.
- [I] (h) AWNINGS AND LOUVRES (subclassification C-14h): The fabrication and installation of awnings and louvres made of wood, fabric, plastics, metal or other acceptable products.
- [(j) LOUVRES (subclassification C-14j): The fabricaiton and installation of louvres made of wood, fabric, plastics, metal or other acceptable products.]
- [k] (i) RIGGING AND CRANES (subclassification C-14i): Rigging as it is customarily accepted by contractors and the operation of cranes.
