2. DISCIPLINARY HEARING:

ELISHA ELWOOD DURHAM, LICENSE NO. 53886

Licensee was present with counsel, Brian Boggess.

Hearing Officer Clark found the respondent Elisha Elwood Durham, dba Elisha Elwood Durham, license number 53886 guilty of the second, third, fourth, fifth, sixth, seventh, eighth and ninth causes of action and dismissed the first cause of action. Mr. Durham was assessed a fine of \$2,500. Investigative costs were assessed in the amount of \$1,000. An 18-Month Letter of Reprimand will be placed in Mr. Durham's license file. Half of the fine and costs, \$1,750, is due within 90 days and the remaining fine and costs, \$1,750, is due within 180 days or license number 53886, Elisha Elwood Durham, dba Elisha Elwood Durham will automatically be suspended.

3. DISCIPLINARY HEARING:

DREAMSCAPES, INC., LICENSE NOS. 53928, 50814 AND
PLATINUM CONCRETE & MASONRY, LLC, LICENSE NO. 53994

Licensee was present with counsel, Michael Harker.

Hearing Officer Clark found the respondent Dreamscapes, Inc., Marc Stephan Dudley, President, license numbers 53928 and 50814 and Platinum Concrete & Masonry, LLC, Marc Stephen Dudley, Manager, license number 53994 guilty of all causes of action. Hearing Officer Clark accepted the voluntary surrender of license number 53928, Dreamscapes, Inc. and license number 53994, Platinum Concrete & Masonry, LLC. License number 50814, Dreamscapes, Inc. will be activated as soon as the bond is paid. This matter is continued for 90 days.
