Hearing Officer Scroggins found the Respondent Daniel Amster, Manager and Jak Fredrick, Manager, Dakem & Associates, LLC, license number 47757, guilty of violation of NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with Notice to Correct; NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include license number and monetary limit on contracts; NRS 624.3016(6) failure to comply with NRS 624.600; NRS 624.3011(1)(b)(1) disregard of the Building Laws of the State. Mr. Amster and Mr. Fredrick were assessed a fine of \$250.00 for the First, Fifth, Sixth and Ninth Causes of Action and a fine of \$100.00 for the Third Cause of Action for a total fine of \$1,100.00. The Second, Fourth, Seventh, Eighth, Tenth and Eleventh Causes of Action were dismissed. Investigative costs were assessed in the amount of \$9,991.00. Mr. Amster and Mr. Fredrick are to pay restitution to the homeowner in the amount of \$11,720.00. Fines, Costs and restitution are to be paid within 30 days from September 20, 2004 or license number 47757, Dakem & Associates, LLC will automatically be Revoked.
