Hearing Officer Higgins found George Lauren Herbst President of Herbst Station Repair, license number 13211A guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license. Mr. Herbst was ordered to pay a fine of \$2,000.00 for the First Cause of Action; \$1,000.00 each for the Second and Third Causes of Action for a total fine of \$4,000.00; and assessed investigative costs in the amount of \$3,680.00. The Fourth Cause of Action is dismissed. Fines and costs to be paid within 60 days of October 10, 2007 or license number 13211A will be automatically suspended.

Hearing Officer Cavin found Respondent Gary Roy Lehrer President of Dream Creations, dba D C Builders, license numbers 56978 and 60032 guilty of violating NRS 624.301(5) willful failure or refusal to comply with terms of a construction contract or written warranty thereby causing material injury to another and NRS 624.3011(1)(a) disregard of plans and specifications. Mr. Lehrer was ordered to pay a fine of \$5,000.00 each for the First and Third Causes of Action for a total fine of \$10,000.00; assessed investigative costs in the amount of \$1,956.00. The Second and Fourth Causes of Action were dismissed. Fines and costs shall be paid within 90 days of October 10, 2007 or license numbers 56978 and 60032 will be automatically revoked. License number 56978 (B-2 Residential & Small Commercial) is suspended for a period of two years, license number 60032 (C-3 Carpentry) shall remain active, however, licensee was ordered to subcontract with a licensed general contractor for any work performed under the C-3 license, license number 60032.
