Hearing Officer Cavin found Respondent John Kellogg Wahl Owner, dba Wahl to Wahl Construction license number 30510 guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner. Mr. Wahl was ordered to pay a fine of \$500.00 for the First Cause of Action, \$250.00 each for the Third and Fourth Causes of Action for a total fine of \$1,000.00; licensee was ordered to furnish a current financial statement to the Board within 30 days of January 10, 2007; pay investigative costs of \$1,925.00 within 60 days of January 10, 2007 or license number 30510 will automatically be suspended.
