Hearing Officer Hodgson found Respondent guilty of two (2) violations of NRS 624.302(5) failure to respond to a written request from the Board; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; three (3) violations of NRS 624.3013(4) failure to keep bond in force; one (1) violation of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or partner of licensee. The Fifth and Sixth Causes of Action were dismissed. Respondent Red Rock Mechanical, LLC, license number 49665 pleads no contest to the Board's Amended Complaint and stipulates to the revocation of their license. Respondent Vegas Fencing, LLC, dba Royal Fencing, license number 65165 stipulates to the voluntary surrender of their license. Respondent K & D Construction, LLC, license numbers 59309, 59310 and 59311 agrees to pay an administrative fine of \$1,500.00 and investigative costs of \$4,034.00 within sixty (60) days of the March 24, 2010 Board Hearing and to provide a current financial statement with bank verification for all cash accounts that supports the license limits and agrees to be placed on Probation for one (1) year or it shall result in the suspension of license numbers 59309, 59310 and 59311. Red Rock Mechanical, LLC shall satisfy all present and future undisputed claims filed against its license. The Board agrees to dismiss the amended complaint against Vegas General Construction Company and dismiss the complaint against the officers, director, employees or members of Commercial Door Services of Nevada, LLC, S. B. S. Construction Services of Nevada, LLC and Vegas General Construction Company. The Board agrees to dismiss the amended complaint against Commercial Door Services of Nevada, LLC and S. B. S. Construction Services of Nevada, LLC. Commercial Door Services of Nevada, LLC and S. B. S. Construction Services of Nevada, LLC agree to remove their Qualified Employee, Kenneth Daniel Black, Jr. and voluntarily surrender the license. No administrative fines were assessed, investigative costs are in the amount of \$1,000.00 and shall be paid within thirty (30) days of the March 24, 2010 **Board Hearing.**

Hearing Officer Hodgson found Respondent guilty of one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; one (1) violation of NRS 624.3017(1) substandard workmanship; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with Board's Notice to Correct; (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of the license and any monetary limit placed upon his license. The First and Fifth Causes of Action were dismissed. Respondent was assessed a total fine of \$2,500.00 and investigative costs of \$1,670.00. Fines and costs are due within thirty (30) days of the March 24, 2010 Board Hearing or license number 73696, A. A. C. A., LLC, dba Mr. Rooter Plumbing shall be revoked.

Respondent was assessed a total fine of \$2,500.00 and investigative costs in the amount of \$1,706.00. License number 46816 was revoked. Respondent is ordered to pay full restitution to the damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus fines and investigative costs prior to consideration of future licensure.
