Respondent was assessed a fine of \$500.00 for each of the First and Third Causes of Action and investigative costs of \$1,456.00 plus the cost of the transcript. Respondent was assessed a fine of \$500.00 for each of the First, Second and Third Causes of Action and investigative costs of \$1,368.00. If both companies are in bankruptcy, no fines or costs will be assessed. License number 23274, Pioneer Woodworking, LTD and license number 71164, Sin City Millworks, LLC were revoked.
