**Hearing Officer Drake found the Respondent First Americans, license number 68139 guilty of violating NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license. Respondent to pay a fine of \$250.00 for the First Cause of Action and reimburse the Board for investigative costs in the amount of \$1,920.16 within sixty (60) days of December 1, 2010 or license number 68139 will automatically be revoked.**

Hearing Officer Drake found the Respondent Raw Enterprises LLC, license number 60746 guilty of violating NRS substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct and NRS 624.3013(3) failure to establish financial responsibility. Respondent was ordered to pay a fine of \$500.00 for the First Cause of Action and \$50.00 for the Second Cause of Action for a total fine of \$550.00; and reimburse the Board for investigative costs in the amount of \$2,549.16; reimburse Carrie Winchell \$2,263.00 for labor and \$2,377.51 for the original flooring to be paid within sixty (60) days of December 1, 2010 or license number 60746 will automatically be revoked. The Third and Fourth Causes of Action are dismissed. No fine will be imposed on the Fifth Cause of Action if the Respondent indemnifies the license within sixty (60) days or license number 60746 will automatically be revoked.
