Hearing Officer Ellison found Respondent Jim Corcoran Enterprises Inc dba, Drain Openers Jims Plumbing & Heating, license number 54606 guilty of violating NRS 624.720(3) advertising as a contractor and not including the correct name of its company and the number of its license; NRS 624.3014(1)(a) acting in the capacity of a contractor under any license issued hereunder except in the name of the licensee as set forth upon the license and NRS 624.3013(3) failure to establish financial responsibility. Hearing Officer Ellison ordered Respondent's license remain suspended. Respondent was ordered to pay a fine of \$500.00 each for the First, Second and Fourth Causes of Action for a total fine of \$1,500.00 and reimburse the Board for investigative costs in the amount of \$1,986.00 within sixty (60) days from March 17, 2010 or license number 54606 will be revoked. Respondent was ordered to remove "Jim's" from the dba designation; all vehicles and advertising; provide a current financial statement that supports the monetary license limit and obtain a qualified individual for its license within sixty (60) days from March 17, 2010 or license number 54606 will be revoked. Hearing Officer Ellison ordered the Respondent to pay a fine of \$500.00 for the First Cause of Action, \$250.00 for the Second Cause of Action and \$500.00 for the Third Cause of Action for a total fine of \$1,250.00; reimburse the Board for investigative costs of \$2,403.00 within sixty (60) days of March 17, 2010 or license number 10357A will be revoked.
