Hearing Officer Wells found Respondent guilty of one (1) violation of NRS 624.3017(1) substandard workmanship; one (1) violation of NRS 624.3013(4) failure to keep bond in force and two (2) violations of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or partner of licensee. Respondent was assessed a fine of \$500.00 for the First Cause of Action; a fine of \$250.00 for the Sixth Cause of Action for total fines of \$750.00 and investigative costs of \$4,325.00. The Second, Third, Fourth, Fifth and Seventh Causes of Action were dismissed. Respondent Lifeguard Pool Maintenance, dba Lifeguard Pools shall make monthly payments beginning March 30, 2011 of eleven (11) payments of \$422.92 and a twelfth and final payment of \$422.88. If Respondent fails to make its scheduled monthly payment, license numbers 49357, 58172 and 73613 shall be suspended until the scheduled payment has been made current. Respondent Lifeguard Pool Maintenance, dba Lifeguard Pools shall have all repairs completed by February 25, 2011 except for the spray decking. The license limit of license number 49357 shall be lowered to \$150,000.00 and license number 58172 shall be lowered to \$200,000.00.
