License number 74483 is revoked. Respondent must pay an administrative fine of \$750.00 and investigative costs of \$463.78.

Hearing Officer Wells ordered Respondent to provide a current financial statement to the Board within six (6) months and submit to a business review within six (6) months.

Licensee must provide a current financial statement supporting the limit and increased bond amount of \$10,000.00 prior to reactivation of the license. Respondent shall submit to a business review within six (6) months. If the business review is satisfactory, the bond requirement may be lowered to \$5,000.00.
