Message from Chairman Jan Leggett

And enforcement initiatives have gained momentum through improved partnering and outreach efforts with local law enforcement.

While these initiatives began as a stepping stone idea in July 2014, each is now a permanent cornerstone in our daily operations. Another great benefit of a strategic plan. Just when you think you've reached the top of the ladder, you realize that there is always another opportunity to climb even higher. I welcome you to follow us through this year's journey as we pull up our sleeves, kick up our feet, and begin our trek to new heights!

Message From Margi Grein, Executive Officer

At our July Board meeting, members elected Jan Leggett to serve as new chairman for the 2015-16 fiscal year. It was such a pleasure working under the leadership of former chairman Guy Wells, and I am equally excited to see the new directions Mr. Leggett will take us in the months to come.

While we move forward with the Board's full agenda of goals for the 2015-16 fiscal year, I want to pause and reflect on our activities during the recently completed year.

NSCB instituted several improvements to help the public engage licensed contractors, expanded its efforts to address the state's unlicensed contractor problem and streamline processes to make the licensing easier for legitimate contractors.

For instance, the Board's Licensing Department improved its service to consumers by making an enhanced search feature available on our website. The search makes it easier for homeowners to find appropriately licensed contractors by including options to search by classification and by county.

In response to industry trends, the Board established a temporary regulation for a new B-6 classification that covers tenant improvement work in high rise buildings. Staff also worked with subject matter experts to develop a B-6 examination, which was implemented earlier this year.

Many of the Board's sting



operations targeting unlicensed contractors are highlighted in this issue of Horizons. These undercover initiatives combined the Board's resources with those of several local law enforcement agencies. Additionally, the Board collaborated with California on the 4th annual Border Blitz operation, as well as nine other states across the nation on a sting targeting unlicensed advertisements on mediums such as Craigslist. These partnerships reinforce the Board's commitment to public safety and help to send a clear and strong message that unlicensed activities will not be tolerated.

Toward the beginning of the fiscal year, at a time when solar technology was becoming more prevalent in Nevada's communities, the Board began noticing an increase in the number of complaints and violations related to solar construction activities. In an effort to get ahead of the issue, the Board began

working to educate consumers about the importance of hiring a licensed Nevada contractor during homeowner forums in partnership with NV Energy. We also reached out directly to the solar industry to better engage with them on various compliance requirements and how the industry can assist us in combating any unlawful activities being noticed.

As part of its effort to re-main current on industry and regulatory practices, the Board participated in a series of trainings throughout the year. Two of the most informative and rewarding were presented by the National Judicial College and the Federal Association of Regulatory Boards (FARB) on the role and responsibilities of licensing boards.

Finally, the Board was actively engaged throughout the 2015 session of the Nevada State Legislature, testifying in various committee hearings, meeting with legislators and responding to legislative inquiries. While only one of the Board's bills was successfully passed into law, the overall outcome rendered positive results and changes for NSCB. We were pleased to see the Legislature and Governor supported one initiative to enhance penalties for unlicensed contracting activities - an effort we hope will further deter this behavior in our communities.





Licensing

Overall, Fiscal Year 2014-15 demonstrated a relatively flat trend across all licensing sectors.

Positive declines in the number of application denial and financial responsibility hearings held during the year were noticed as a result of implemented programs aimed at working more actively with the applicant to address financial issues.

Active licenses are up a modest 0.8 percent, new licenses issued are up 10 percent from last year, and single project increase requests saw an increase of 35 percent over FY 2013-14.







Compliance tips for Nevada's licensed contractors

The Nevada State Contractors Board reminds licensed Nevada contractors of their responsibility to include specific information when advertising services. Per NRS 624.720(3), "All advertising by a licensed contractor must include the name of the contractor's company and the number of the contractor's license."

NSCB frequently monitors a number of print and online media, including Angie's List, Craigslist, online bulletins, local and statewide publications, etc. and has begun to see an increase in licensed contractors failing to include their license number in their advertisements.

Advertisements are often a homeowner's first line of referral when seeking a contractor to hire. Including the information gives property owners the information they need to make informed decisions to engage with contractors with whom they will have confidence.

Contractors can use their license as a marketing tool, highlighting to potential customers that licensure shows the company has demonstrated high levels of skill, experience and knowledge and has complied with all workers compensation, liability, and insurance laws.

Per NRS 624.520, contractors also are required to include information on NSCB's Residential Recovery Fund on their bids and contracts. The following passage would be sufficient:

Payment may be available from the Residential Recovery Fund if you are damaged financially by a project performed on your residence pursuant to a contract, including construction, remodeling, repair or other improvements, and the damage resulted from certain specified violations of Nevada law by a contractor licensed in this State. To obtain information relating to the Residential Recovery Fund and filing a claim for recovery from the Recovery Fund, you may contact the State Contractors Board at the following locations:

MILITARY ASSISTANCE PROGRAM

For veterans making the transition into civilian employment and spouses of active-duty military personnel relocating with their service members to Nevada

- A dedicated, specially trained NSCB staff member to evaluate transferable military training and experience from all branches of the military that meet minimum contractor licensing requirements.
- Military experience and training will be considered along with college credit when the Board evaluates acceptable technical education levels for license applicants.
- Military spouses' current records of licensure will be evaluated to determine whether he/she is eligible for waiver of certain experience requirements for licensure.

Board addresses solar concerns

The Nevada State Contractors Board is working to inform solar contractors and consumers of pertinent regulations and is¬sues. Using a series of outreach presentations to contractors and homeowners interested in solar construction, the Board reaches out to solar industry groups to inform contractors and vendors of noticed violations within the industry.

This proactive approach to prevent further compliance is—sues from being reported to the Board also afford the Board an opportunity to initiate two-way dialogue with the industry and seek collaborative solutions to combating unlicensed activities occurring from out-of-state businesses.

The outreach effort's other important focus is to engage homeowners and provide them cautionary tips when considering solar for their home to ensure they maintain the protections offered by a licensed contractor.

In partnership with NV Energy and various industry groups, the Board was present to answer questions from homeowners and share with them the warning signs of unscrupulous contractors.

The Board cautions home-owners to be aware of three particular areas of concern:



3rd party financing -While not an unusual or unethical practice, NSCB cautions homeowners to be diligent in reading through the final contract language before signing, as some cases investigated by NSCB have noticed a bait and switch tactic. In these instances, homeowners are often verbally told their interest rate would be 'X' only to find out that the interest rate in the actual contract was significantly higher or had language that ballooned the payment after the first few months.

Out of State Companies

- Only companies with Nevada contractor's licenses are allowed to install solar equipment. Out of state contractors have been known to hire unlicensed sales representatives solicit solar projects, who then contract for the work to be in-

stalled.

Product Sustainability

- Nevada's nearly year-round sunshine makes it ideal for solar, however, because the technology is still relatively new, it is uncertain how Nevada's harsh wind and heat will impact the solar panels over long periods of time. Adding to this is the unknown longevity of many businesses who became established during the boom. Will their business stay in operation to fulfill the multi-year warranties afforded to homeowners? If not, what options will homeowners have when their products fail or need maintenance?

These cautionary discussions are intended to help homeowners have thoughtful and informed conversations with their contractors as they consider purchasing solar for their homes.

29 cited in NSCB statewide sting

On June 23, the Nevada State Contractors Board partnered with the North Las Vegas Police Department and Washoe County Sheriff's Office to conduct three undercover sting operations across the state. The stings resulted in the citing 29 unlicensed contractors for alleged violations of contracting and/or advertising without licenses. Also, one licensed contractor was identified for further investigation.

The stings were part of a nationwide event coordinated by the National Association of State Contractor Licensing Agencies. NSCB joined nine states across the country in targeting individuals illegally advertising services that require valid contractors' licenses on online bulletins, such as Craigslist, Angie's List, and social media sites.

"Contracting without a license is a serious criminal offense that creates tremendous risk of monetary loss and personal safety to property owners," said NSCB Executive Officer Margi A. Grein. "Teaming up with other states across the nation to educate and cite unlicensed contractors for their unlawful activities, while also raising awareness among homeowners of the importance of hiring licensed contractors is a great opportunity that we look forward to participating again in the future."

Legitimate Nevada contractors can help NSCB spread the word to homeowners, urging caution when responding to advertisements for repair and maintenance services posted to online sources such as Craigslist. Licensed contractors can protect their businesses by reminding homeowners to keep several points in mind:

- All plumbing, electrical, heating, ventilation and air conditioning services can only be performed by a licensed contractor. These services cannot be performed by a "handyman."
- All advertisements for work requiring a contractor's license must have a contractor's license number posted on the advertisement.
- Homeowners who contract with unlicensed contractors are not eligible for the Residential Recovery Fund.
- Contracts entered into with an unlicensed contractor are not recognized/valid in Nevada.
- Always verify the contractor's license number on NSCB's website at www.nscb.nv.gov.

Unlicensed contractor gets probation

On May 4, Elko District Court sentenced Michael Scott Hoover of Hoover & Sons Handyman to 40 months in Nevada State Prison after Hoover pled "no contest" to a felony charge of diversion of funds. This sentence was later suspended and Hoover was placed on five years' probation and ordered to pay \$2,500 restitution to his victim. The charges stem from a 2013 NSCB investigation after an elderly man hired the unli-

censed contractor in 2012 to stucco the walls of his building. Hoover misled the victim to think he was a licensed contractor by including a fictitious contractor's license number on his business card. Hoover received \$2,500 from the victim to begin the project and another \$2,500 to purchase materials to complete the job.

Hoover abandoned the project after refusing to reimburse the victim \$2,500 for materials.

Board revokes, fines licenses

The Nevada State Contractors Board took action against several licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its April, May and June hearings in Reno and Henderson.

Southwest Stone and Tile, Inc., license numbers 46544 (tiling) and 46545 (install terrazzo & marble), based out of Las Vegas, Nev., had their probationary status lifted, and all causes of action were dismissed. If the Board receives any new, substantiated money owing or workmanship complaints, both licenses shall be revoked.

Silver State Marble, LLC, license numbers 62776 (tiling) and 62894 (install terrazzo & marble), based out of Las Vegas, Nev., stipulated to the revocation of its licenses.

Alpine Construction & Development, LLC, dba Energy Efficient Contracting, license number 77505 (residential & small commercial), based out of Las Vegas, Nev., was found in violation for failure to include the monetary limit or license number on a contract or proposal, failure to keep in force a bond or cash deposit, failure to notify the Board of a change in personnel or address within 30 days of the change, and failure to establish financial responsibility. Licensee was fined \$2,000 and assessed investigative costs. The license was revoked.

Professional Handyman Services, dba Flooring and Construction Services, license number 74331 (carpentry) based out of Las Vegas, Nev., was found in violation for attempting to assign, transfer or otherwise dispose of a license or permit an unauthorized use of a license, failure to comply with terms of a construction contract thereby causing material injury to another, failure to take appropriate corrective action, abandonment of a construction project without legal excuse, failure to notify the Board of a change in personnel or address within 30 days of the change, willful disregard of the laws of the state regarding industrial insurance, acting

as a contractor without proper licensure, failure to keep in force a bond or cash deposit, and failure to establish financial responsibility. Licensee was fined \$15,000 and assessed investigative costs. The license was revoked.

Double A Electric, LLC, license number 57578 (electrical & residential wiring) based out of North Las Vegas, Nev., was found in violation for failure to establish financial responsibility, failure to comply with a written request by the Board, and failure to respond to a written request from the Board. Licensee was fined \$8,000 and assessed investigative costs. The license was revoked.

Kurt Karl Krug, dba Great Basin Deck & Shade, license numbers 72813 (carpentry & repairs) and 72097 (awnings & louvers) based out of Mound House, Nev., was found in violation of acting beyond the scope of the license, failure to pay for any materials or services, failure to provide required mandatory disclosures to the homeowner, and failure to establish financial responsibility. Licensee was fined \$5,000 and assessed investigative costs. Licenses are suspended until fines and costs are paid. Failure to comply within 60 days will result in the revocation of both licenses.

Francis H. Steiner, Owner, dba Nevada Sign, license number 45966 (erecting signs), based out of Henderson, Nev., was found in violation for willful disregard of the building laws of the state. Licensee was fined \$1,000 and assessed investigative costs. Failure of the licensee to pay the fines and costs within the allocated time frame will result in the license being suspended.

EPCON Electric Nevada, LLC, license number 79838 (electrical contracting), based out of Phoenix, Ariz., was suspended pending the next disciplinary hearing, which was continued for 90 days.

M & M Interiors, LLC, license number 78553 (drywall, sheet metal studs, and acoustical tile), based out of Henderson, Nev., was found in violation for failure to comply with an order of the Board, failure to acquire a business license, failure to include license number or monetary limit in a bid or contract, failure to comply with a written request by the Board, aiding or abetting an unlicensed person, failure to display name and license number on a motor vehicle, and failure to establish financial responsibility. The license was revoked. Licensee was fined \$2,350 and assessed investigative costs.

Alternative Drilling Company, LLC, license number 73955 (drill wells, install pumps, pressure tanks and storage tanks), based out of Lamoille, Nev., was found in violation for failure to establish financial responsibility. Licensee was fined \$500 and assessed investigative costs. The license is suspended until a current financial statement that supports the license limit is provided to the Board.

G Built Construction, LLC, license number 71766 (carpentry) based out of Sparks, Nev., was found in violation for substandard workmanship, failure to take appropriate corrective action, acting beyond the scope of the license, failure to include the Residential Recovery Fund information on a contract or proposal, failure to pay any money due for any materials or services rendered, failure to establish financial responsibility. The license was revoked. Licensee was fined \$2,350 and assessed investigative costs.

Imtiaz Ahmed, dba Lobo Roofing, license number 70178 (roofing) based out of Reno, Nev., was found in violation for substandard workmanship, failure to include the monetary license limit or license number on a contract or proposal, failure to include the Residential Recovery Fund information on a contract or proposal, and commencing work on a project without obtaining the necessary building permits. Licensee was fined \$2,500 and assessed investigative costs. Failure of the licensee to pay the

fines and costs within the allocated time frame will result in the license being suspended.

Sierra Construction & Development, LLC, dba S C D Framing, license number 71348 (carpentry) based out of Sparks, Nev., was found in violation for substandard workmanship, failure to take appropriate corrective action, failure to include the Residential Recovery Fund information on a contract or proposal, failure to pay for materials or services, lending the license to an unauthorized individual who is not on the license, failure to prosecute a construction project or operation thereby causing material injury to another, diversion of funds, and failure to establish financial responsibility. The license was revoked. Licensee was fined \$10,150 and assessed investigative costs.

Sierra Development, license number 68759 (residential & small commercial) based out Sparks, Nev., was found in violation for substandard workmanship, failure to take appropriate corrective action, failure to include the Residential Recovery Fund information on a contract or proposal, failure to pay for materials or services, lending the license to an unauthorized individual who is not on the license, and failure to establish financial responsibility. The license was revoked. Licensee was fined \$7,600 and assessed investigative costs.

Jordan River Construction, Inc., license number 77295 (carpentry) based out of Spring Creek, Nev., was found in violation for substandard workmanship, failure to take appropriate corrective action, willful disregard of the building laws of the state, committing a fraudulent or deceitful act, failure to respond to a written request from the Board, failure to prosecute a construction project or operation thereby causing material injury to another, diversion of funds, acting beyond the scope of the license, advising construction projects beyond the scope of the license, and failure to establish financial respon-

Knighton Construction, LLC, license number 11802A (residential & small commercial) based out of Sparks, Nev., was found in violation for substandard workmanship, failure to complete a construction project in accordance with the plans and specifications, failure to complete a construction project or operation for the price stated in the contract, and failure to establish financial responsibility. The license was revoked. Licensee was fined \$2,000 and assessed investigative costs.

Millhouse Repair, LLC, license numbers 75322 (carpentry) and 76249 (roofing & siding) based out of Spring Creek, Nev., was found in violation for acting beyond the scope of the license, failure to include the Residential Recovery Fund information on a contract or proposal, failure to notify the Board of a change in personnel or address within 30 days, failure to include the monetary license limit or license number on a contract or proposal, failure to keep in force a bond or cash deposit, and failure to establish financial responsibility. The licenses were revoked. Licensee was fined \$2,450 and assessed investigative costs.

Revcon, LLC, license numbers 73824 (concrete contracting) and 75703 (sealing and striping impermeable paving surfaces), based out of Las Vegas, Nev., was found in violation for failure to establish financial responsibility and failure to comply with a request from the board. Licensee was fined \$750 and assessed investigative costs. Failure of the licensee to pay the fines and costs within the allocated time frame will result in the license being suspended.

S.E.S. Roofing, Inc., license number 75500 (roofing & siding), based out of Henderson, Nev., was found in violation for failure pay for materials or services, failure to establish financial responsibility, and constructing or repairing an mobile home without the proper license. Licensee was fined \$1,500 and assessed investigative costs. Failure of the licensee to

One Management of Nevada, Inc., dba One Energy of Nevada, license number 78074 (solar contracting) based out of Tempe, Ariz., was found in violation for failure to establish financial responsibility, failure to notify the Board within 30 days of a change in address or personnel; failure to respond to a request from the Board, and failure to comply with a request for information or records. The license was revoked. Fines and investigative costs were not assessed owing the company's bankruptcy proceedings.

The license was revoked. Licensee was fined \$750 and assessed investigative costs.

M2V, Inc., dba Toovey Tile Professionals, license number 68162 (tiling) based out of Las Vegas, Nev., was found in violation for failure to establish financial responsibility. The license was revoked. Licensee was fined \$500 and assessed investigative costs.

Rick Wayne Rainey, owner, dba R.W. Rainey Construction, license number 7633 (general building) based out of Las Vegas, Nev., was found in violation for failure to establish financial responsibility, failure to a request from the Board, and failure to comply with a request for information or records. The license was revoked. Licensee was fined \$1,500 and assessed investigative costs.

Be a "card-carrying" licensed contractor

The Nevada State Contractors Board continuously reminds property owners to check contractors' pocket identification cards before agreeing to proposals, signing contracts or allowing anyone to perform work on their homes or businesses.

As these outreach efforts continue, NSCB also encourages all licensed contractors to carry the pocket cards while on the job and especially in situations where they think they might be soliciting business or.

The hard plastic license pocket cards recently were redesigned to include NSCB's logo and the state seal in addition to the license number, business name, classification(s), and license expiration date. One card is issued upon issuance and renewal of the license. NSCB allows con-

tracting companies to purchase additional cards at \$10 each to distribute to key on-site personnel to use when potential customers inquire about services.

Board changes boost customer service

During the just-completed fiscal year, the Nevada State Contractors Board revamped its general building exam administered to contractors seeking their B-classification licenses.

The change, implemented in October 2014 came as a result of an occupational analysis for the exam undertaken by building officials and subject matter experts from the general building trade.

Reference materials for all general engineering and general building were also updated, where applicable.

Additionally, staff worked with subject matter experts on the development of a B-6 classification trade examination in connection with the adoption of new temporary regulations. This examination was released in May 2015 and consists of 80 questions in 10 subject areas.

In another effort to better serve NSCB customers and improve staff response times to calls received, the Board' reconfigured its call center to improve routing of calls, leading to increased answering speeds and fewer dropped calls.

Since being implemented, staff members have recorded approximately 10,000 calls per quarter with an abandoned call rate of not more than 1.39 percent.

In an effort to streamline the appeals process, NSCB's Licensing Department implemented several changes during the fiscal year:

- Modifications to the Notice of Hearing
- Providing each staff-

- denied applicant a Statement of Obligations and Rights
- Clarified requirements to ensure timely submission and submittal of supplemental information and evidence
- Changes to the format and duration of hearings.

Also, the final notice of denial includes language that more clearly states the findings of the case and the reasoning licensing the applicant would pose a risk to the public. The additional time invested by staff in working with applicants to resolve potential issues is proving successful, as there was a 54 percent decrease in denial hearings over last year.



Nevada Contractor's Checklist

The following information is provided to help Nevada Contractors work within the law. For full text of laws that affect contracting in Nevada, see The State of Nevada "State Contractors Board Handbook," Chapter 624 of the Nevada Revised Statutes and Chapter 624 of the Nevada Administration Code. Contact the Nevada State Contractors Board for a copy.

Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Keep your bond current. NRS 624.270
Check to ensure that licenses or persons with whom you contract are valid and active. NAC 624.650
Be sure name of business under which contractor is contracting is the same as the license number. NRS 624.305
Be sure the amount of the bid or contract is within the monetary limit of the contractor. NRS 624.3015(2)
Be sure that the contract is within the scope of work/license classification. NRS 6243015(3)
Know what you are contracting for, verify terms of the contract, and comply with terms of the contract. NRS 624.3013(1)
If it is not in your written contract, it doesn't exist. Make sure all change orders are in writing and signed by all parties. NRS 624.3013(1)
Include Residential Recovery Fund Disclosure on all residential contracts. NRS 624.520
Provide customers with required Notice to Owner Disclosure. NRS 624.600(1)(2) and (3) as described in NAC 624.693 & NAC 624.6932
Make sure your license number is on all business advertisements, including vehicles, business cards, letterhead, signage, directories, newspapers, website, etc. NRS 624.720
Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Your license number should be approximately 1 1/2 inches on your motor vehicle. NRS 624.288
If your address or other pertinent information about the business changes, notify Contractors Board in writing within 30 days, NAC 624.640(3)
