Message from Chairman Guy M. Wells

Message From Margi Grein, Executive Officer

The beginning of the year is always an exciting time for the Board. It marks our halfway point in meeting the goals and objectives of our fiscal-year strategic plan and gives us the opportunity to gauge our progress toward our goal of becoming a model regulatory agency.

During the first two quarters of the fiscal year, we have focused on solving several technological challenges regarding data storage, transfer and security. We also have leveraged new opportunities

to improve our customer service offerings and internal operations.

We are in the process of trying to make our services to contractors more user-friendly. This includes a focus on expanding our online resources, automated forms and applications and training staff members to meet the everchanging needs of our customers.

As always, we have worked to eradicate unlicensed contracting in order to protect property owners from poor workmanship and business practices and shield legitimate, licensed contractors from unfair and illegitimate competition. Toward this end, staff members have built a greater understanding and created strong partnerships that promote and take our mission of protecting the health, safety, and welfare of the public to new heights. At a meeting of the Nevada Sheriffs and Chiefs Association, our investigative team highlighted the ways law enforcement can combat unlicensed contracting activities in the course of their dayto-day duties, while enhancing the lines of communication with Board investigators.

These outreach efforts led to great



collaboration in sting events the Board conducted in both the north and south ends of the state during the quarter. The results of those operations are highlighted in this issue. The Las Vegas Metropolitan Police Department and the Reno Police Department participated in the stings and arrested three suspects on warrants for fraud, felony narcotics possession, and an NSCB gross misdemeanor.

As also reported in this issue, the Nevada Highway Patrol

made several arrests on outstanding warrants after it was called in during the course of NSCB investigations.

These developments will continue throughout the fiscal year, and we are confident our efforts will lead us toward even greater fulfillment of our mission to protect the health and welfare of the public.

In addition to our law enforcement partnerships, the Board has actively engaged itself in a number of collaborative opportunities with government, industry and private sector representatives, each of which has generated stronger communication, increased understanding and renewed expectations for ongoing initiatives.

This includes preparations for the 2015 session of the Nevada State Legislature, which will begin in February. Board executives have met with legislators to introduce them to the Board, share the mission and public services we have to offer, and provide them with opportunities to partner with the Board on outreach initiatives for their constituencies.





Licensing

NSCB's Licensing Division is responsible for assisting individuals interested in obtaining a Nevada contractor's license, as well as processing license applications and ensuring all necessary qualifications are met.

During the quarter, the Board conduced a workshop and hearing to present information and solicit feedback regarding the Board's plan to adopt a new license subclassification, B-6, which would permit remodeling of interior commercial spaces.

The Board also received approval for language concerning Regulation R019-14 clarifying the criteria the Board uses for imposing fines.







Enforcement - Unlicensed Contractors





Stings net 20 citations, 3 arrests

During undercover sting operations in October, the Nevada State Contractors Board cited 20 alleged unlicensed contractors for violations of Nevada Revised Statutes 624.700 (contracting without a license) and NRS 624.720 (advertising without a license).

Local police departments

assisting with the operations in Reno and Las Vegas arrested three suspects on various charges. The Las Vegas Metropolitan Police Department arrested Kamyar "Kevin" Moradi on an NSCB gross misdemeanor warrant and Michael Lucero on a felony warrant for narcotics possession. The Reno Police

Department arrested William Sanborn, a former licensed contractor, on an outstanding fraud warrant. Another alleged suspect, Timothy Penn, was cited twice for contracting without a license, after visiting both Reno sting locations,

which were located two doors apart, on the same day.

"The Nevada State Contractors Board extends its appreciation to the Las Vegas Metropolitan Police Department and Reno Police Department for their participation in our sting events," stated NSCB Executive Officer Margi Grein. "Being able to partner together on public safety initiatives sends a clear message that unlicensed contracting activities are serious crimes and will not be tolerated in our communities."

According to Nevada law, all electrical, plumbing, air conditioning and heating work must be performed by licensed contractors. All work in other



trades requires a license if the value of the project – labor and materials – totals \$1,000 or more or requires a building permit. The Board's criminal investigators conducting stings use the interactions to encourage unlicensed contractors to obtain their contractor's licenses while also fulfilling the

Board's mandate to protect the health, safety, and welfare of the public.

NSCB encourages anyone who comes across unlicensed contracting activities to report the information to NSCB's Unlicensed Contractor Hotline: (702) 486-1160 or (775) 850-7838, or the Board's mobile application. Details to provide the Board, when available, include the unlicensed contractor's name, address (business and/or physical location where work is being performed), phone number, vehicle description, license plate, business card and/or advertisement, contracts signed by the unlicensed individual, etc.

MILITARY ASSISTANCE PROGRAM

For veterans making the transition into civilian employment and spouses of active-duty military personnel relocating with their service members to Nevada

- A dedicated, specially trained NSCB staff member to evaluate transferable military training and experience from all branches of the military that meet minimum contractor licensing requirements.
- Military experience and training will be considered along with college credit when the Board evaluates acceptable technical education levels for license applicants.
- Military spouses' current records of licensure will be evaluated to determine whether he/she is eligible for waiver of certain experience requirements for licensure.

New case results in 3 counts for unlicense activity

A Nevada State Contractors Board investigation led to the arrest of Kris Salomonson for engaging in business or submitting a bid without a license.

The current complaint uncovered the suspect, who had been evading law enforcement in the wake of two similar incidents that resulted in two active bench warrants for Salomonson.

The Nevada Highway Patrol arrested Salomonson at the NCSB Henderson office after he was called in to discuss the current charge. That case resulted in a third contracting without a license gross misdemeanor charge being submitted to the district attorney.

Board expands education initiatives

Thanks to the success of the Nevada State Contractors Board's Community Managers presentations, the Board has seen opportunities to educate other groups on their rights and responsibilities when hiring contractors for repair, maintenance or expansion of common areas.

Staff soon will present a similar discussion with a non-profit community group that works with the state to assist in coordi-

nating Americans with Disabilities Act-compliant construction services. The Board is in the process of developing a tailored presentation for the organization's staff.

It is hoped that the chance to educate those who assist in the hiring of contractors in the scope of their day-to-day activities will give NSCB a forum to promote the hiring of licensed contractors and encourage the public at large to take advantage of the Board's services.


In November, the Board further promoted its enforcement program, and public safety purpose and operations at a meeting of the Nevada Sheriffs and Chiefs Association. This was an opportunity to emphasize the similarities between the Board's mission and that of law enforcement. The presentation included information on how officers can engage with the Board through sting events, how to recognize construction crimes and more.

Big Board bust in rural Nevada

The citation of an unlicensed contractor in Spring Creek led to multiple additional charges against licensed contractors with whom the suspect collaborated.

Events began to unfold near the end of 2013, when NSCB investigators received an anonymous complaint about a person without a valid Nevada contractor's license allegedly performing work at various locations around Spring Creek. Upon visiting the job sites, investigators identified the suspect and issued him a citation for contracting without a license.

The investigation didn't end there, however. Following up on information they obtained from witnesses and interrogation of the original suspect, Board investigators learned the suspect had been working as an "independent contractor" for multiple license holders. Entering into agreements such



as "general power of attorney" and "authorization to act as agent," the licensed contractors allowed the unlicensed person to pull permits, schedule inspections, perform residential construction work and undertake all acts on behalf of their businesses.

Further evidence uncovered that this case was not the only

"independent contractor" being used by the licensees. As many as 18 unlicensed contractors were found to be performing work under such illegal agreements with the group of licensees.

The expanded investigation resulted in eight misdemeanor charges against the original unlicensed individual being submitted to the Elko district attorney's office. He was charged with engaging in business or submitting a bid without a contractor's license. Additional misdemeanor cases were forwarded to the district attorney against the other unlicensed contractors the case uncovered.

All the licensed contractors involved were found guilty of aiding and abetting unlicensed contractors and attempting to assign, transfer or otherwise dispose of a license or permit its unauthorized use.

Compliance tips for Nevada's licensed contractors

- Prominently display your license number and monetary limit on all bids, contracts and marketing material, including trade show displays, service vehicles, business cards, letterhead and websites.
- Notify the Board of any changes to your address, qualifying person or other relevant information within the statutory timeframe.
- Including the relevant Residential Recovery Fund language on all residential contracts.
- Never advertise, bid or contract for work outside the scope or monetary limit of your license. When hiring subcontractors, always check that their licenses are active and valid for the work they are to perform.
- Don't forget to renew your license online. You also can find instructions on expanding the license's scope or limit, changing a business address or a qualified person and more at http://www.nscb.nv.gov/contractor_apps.html.

Longtime Board target arrested on felony charge


The Nevada Highway Patrol arrested a longtime person of interest to the Nevada State Contractors Board on Oct. 30, 2014.

Michael Delbridge had been called for an interview at the NSCB Henderson office and was taken into custody on a felony contracting without a license warrant issued from the Clark County District Attorney's Office.

Delbridge has been the subject of nearly 20 NSCB investigations since the early 1990s. Using business names such as "Design Consultants," "Road-Runner Construction," and "Michael R. Delbridge Co.," Delbridge is accused of obtaining referrals, either from satisfied customers or from accomplices placing advertisements for his services.

Upon contacting a potential customer, Delbridge, it is alleged, claimed to be licensed and insured and asked for a sizable down payment to begin the project. According to NSCB investigators, Delbridge then hired unlicensed subcontractors to begin the work, which was disrupted when he failed to pay them.

In one case, a homeowner, an elderly cancer patient, said she was enticed to "invest" in Delbridge's company, with promises that her investment and interest would be repaid after the projects were completed. Other complainants provided evidence that some work initiated by Delbridge was done incorrectly and would require demolition in order to meet local building codes.

Call routing improves customer service

During the quarter, NSCB's Information Technology department upgraded the routing of customer service calls to an automatic call distribution system. This new method improves customer experience by ensuring calls are sent only to monitored and staffed extensions. Additionally, calls are no longer are sent to a generic voice mailbox. The ACD queues are easily monitored by supervisors to help match staffing levels to call volumes.

NSCB recognizes call for jobs stimulus

During a Nov. 6 press conference at the Nevada State Contractors Board offices, NSCB joined the Nevada Commission on Construction Edu-Associated General Contractors and Nevada Contractors Association, Las Vegas Chapter and AGC of America to shed light on Nevada's construction workforce shortages as a result of the latest economic downturn.

AGC's data, however, does indicate that construction employment is picking up steam, with more than half of the 14,000 new construction jobs coming in the last year. Ken Simonson, chief economist for the Associated General Contractors of America, noted that half of Nevada's construction firms are finding it difficult to fill craft worker positions. Sean Stewart, AGC/NCA Las Vegas Chapter president, highlighted education, training and other workforce development initiatives being offered through their association, calling special

attention to grant funding received from the Commission in recent years as an integral contributor. Commission member Shawn Danoski addressed the commission's responsibility for reviewing program proposals and awarding grant funding from the Construction Education Fund, which has provided more than \$2.7 million in grant awards since its inception. The commission receives its funding from donations and fines

paid by licensed contractors.

"We at the Contractors Board have seen the impact of the economic downturn on the construction community in recent years, and we support the efforts being made by the commission, educational systems, apprenticeship programs and the construction industry as a whole to make workforce development a priority for current and future generations," stated NSCB Executive Officer Margi Grein.

Simonson unveiled AGC's Workforce Development Plan for the 21st Century, which includes calls for government and private-sector investment and legal reforms to increase the construction labor pool: federal funding of technical education, encouraging private funding for craft worker training, immigration reform and public-private partnerships among apprenticeship programs, community colleges, veteran's service providers, etc.

Board reduces Recovery Fund assessment

At its Nov. 13, 2014 meeting, the Nevada State Contractors Board voted to once again reduce the assessment contractors pay into the Residential Recovery Fund. The new, lower rates went into effect Jan. 1, 2015. The Board's decision to lower the rates by 20 percent means licenses with limits of \$1 million or less will pay \$60 per biennium. License limits of more than \$1 million will pay \$200 per biennium. Unlimited licenses will pay \$400 per biennium.

The Nevada State Legislature established the Residential Recovery Fund to provide protection for Nevada homeowners whose properties are harmed by the failure of a licensed contractor to properly perform qualified services including construction, remodeling, repair and improvement. The Board action reduction marks the third fee reduction in three years. The Board previously reduced the assessment at the beginning of 2012 and in July 2013.

Board revokes 11 licenses

The Nevada State Contractors Board revoked 10 licenses and took action against 11 other licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its October, November and December 2014 hearings in Henderson and Reno.

Scott Meek & Son Concrete Co., license number 23322 (concrete contracting), based out of Reno, Nev., was found in violation for failure to pay for materials or services rendered and failure to establish financial responsibility. The license was revoked. Licensee was fined \$1,500 and assessed investigative costs.

Innovative Outdoor Living and Hardscapes, LLC, license number 78036 (residential and small commercial), based out of Sparks, Nev., was found in violation for abandonment of a construction project without legal excuse, acting in the capacity of a contractor beyond the scope of the license, and failure to establish financial responsibility. The license was revoked. Licensee was fined \$1,750, assessed investigative costs, and ordered to pay restitution in the amount of \$20,000.

Custom Design Cabinets of Las Vegas, license number 51576 (finish carpentry), based out of Las Vegas, Nev., was found in violation for substandard workmanship, failure to take appropriate corrective action, failure to comply with a written request from the Board, and failure to establish financial responsibility. The license was revoked. Licensee was fined \$1,250, assessed investigative costs, and ordered to pay restitution in the amount of \$9,400.

Advanced Lighting & Electric, Inc., license numbers 78258 (erecting signs) and 68333 (electrical contracting), based out of Henderson, Nev., was found in violation for failure to notify the Board of a change in personnel or address within 30 days of the change. License number 78258 was voluntarily surrendered. Licensee has 30 days of the hearing to pay fines of \$500 and

investigative costs or license number 68333 will be suspended.

D.C. Stone, LLC, license number 78758 (finishing floors), based out of Las Vegas, Nev., was found in violation for aiding or abetting, combining or conspiring with, allowing a licensed to be used by, and acting as an agent, partner, or associate of an unlicensed person. Licensee was fined \$2,000 and assessed investigative costs. The license limit was reduced to \$10,000.

Tommy Li, owner, dba T&L Stone Design & Remodeling, license number 77778 (finish carpentry) and Tommy Li, owner, dba T&L Stone, license numbers 67842 (tiling) and 77510 (install terrazzo and marble), based out of Las Vegas, Nev., was found in violation for substandard workmanship, failure to include the monetary license limit or license number on a contract or proposal, willful disregard of the state's building laws, contracting beyond the scope of the license, and failure to establish financial responsibility. Licensee was fined \$2,050 and assessed investigative costs. The license limit for license number 67842 was reduced to \$10,000.

1st Choice Storage Solutions, license numbers 54686 (carpentry) and 59785 (painting), based out of Scottsdale, Ariz., was found in violation for lending a license to an unauthorized person who is not on the license, aiding or abetting an unlicensed contractor, and failure to establish financial responsibility. The license was revoked. Licensee was assessed investigative costs.

Be a "card-carrying" licensed contractor

The Nevada State Contractors Board continuously reminds property owners to check contractors' pocket identification cards before agreeing to proposals, signing contracts or allowing anyone to perform work on their homes or businesses.

As these outreach efforts continue, NSCB also encourages all licensed contractors to carry the pocket cards while on the job and especially in situations where they think they might be soliciting business or talking to potential customers.

The hard plastic license pocket cards recently were redesigned to include NSCB's logo and the state seal in addition to the license number, business name, classification(s), and license expiration date. One card is issued upon issuance and renewal of the license. NSCB allows con-



tracting companies to purchase additional cards at \$10 each to distribute to key on-site personnel to use when potential customers inquire about services.

Verify solar suppliers' licenses

In recent months, the Nevada State Contractors Board has been seeing an increase in the number of out-of-state solar manufacturers entering into contracts with licensed Nevada contractors to perform solar installation services for Nevada residents.

Many of the out-of-state manufacturers do not possess Nevada contractors' licenses, and the Nevada contractors performing installation services for such businesses are being disciplined by the Board for aiding and abetting these unlicensed contractors.

NSCB wishes to caution solar and electrical contractors and the industry at large to always verify that the entity being contracted with is a licensed Nevada contractor.

Solar boom reveals shady practices

At a time when the demand is high for solar and renewable energy solutions, aggressive efforts from out-of-state manufacturers to sell and install their products in Nevada homes is becoming more and more rampant.

Over the last year NSCB investigators have seen an influx of cases in which out-of-state manufacturers of solar products will hire independent sales representatives to perform door-to-door solicitations on Nevada homeowners. Unknowing homeowners are enticed by the promises their energy bill will be immediately

and drastically reduced, that they will receive federal tax breaks and that rebates available make the cost a deal too good to pass up. Too often the promises savings fails to materialize.

Unwitting customers sign contracts, and the out-of-state manufacturer hires a Nevada licensed contractor to perform the installation. The licensed contractors are jeopardizing their licenses, and the out-of-state manufacturers are savvy in their methods to distance themselves from the transaction while ensuring they receive payment for the service.

Often out-of-state, third-party lenders finance the projects. The Contractors Board has invetigated cases in which homeowners have agreed to the plan thinking they had locke in at a low rate, only to find out the rate spikes dramatically after the first payment.

This scenario played out during the past quarter, resulting in the revocation of MRI Solar's license. This is a trend likely to increase over the next few years, and the Board will remain vigilant in an effort to protect homeowners and legitimate, licensed contractors.

Nevada Contractor's Checklist

The following information is provided to help Nevada Contractors work within the law. For full text of laws that affect contracting in Nevada, see The State of Nevada "State Contractors" Board Handbook, * Chapter 624 of the Nevada Revised Statutes and Chapter 624 of the Nevada Administration Code. Contact the Nevada State Contractors Board for a copy.

Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Keep your bond current. NRS 624.270
Check to ensure that licenses or persons with whom you contract are valid and active. NAC 624.650
Be sure name of business under which contractor is contracting is the same as the li- cense number. NRS 624.305
Be sure the amount of the bid or contract is within the monetary limit of the contractor. NRS 624.3015(2)
Be sure that the contract is within the scope of wort/license classification. NRS 6243015(3)
Know what you are contracting for, verify terms of the contract, and comply with terms of the contract. NRS 624.3013(1)
If it is not in your written contract, it doesn't exist. Make sure all change orders are in writ- ing and signed by all parties. NRS 624.3013(1)
Include Residential Recovery Fund Disclosure on all residential contracts. NRS 624.520
Provide customers with required Notice to Owner Disclosure, NRS 624.600(1)(2) and (3) as described in NAC 624.693 & NAC 624.6932
Make sure your license number is on all business advertisements, including vehicles, business cards, letterhead, signage, directories, newspapers, website, etc. NRS 624.720
Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Your license number should be approximately 1 1/2 inches on your motor vehicle. NRS 624.288
If your address or other pertinent information about the business changes, notify Contractors Board in writing within 30 days. NAC 624,640(3)
