Hearing Officer Filios found Respondent T C M Construction Services, Inc., dba Cornerstone Roofing, Co., Travis R. McCormick, President, license number 55659 guilty of Two (2) violations of NRS 624.3017(1) substandard workmanship; Two (2) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; Two (2) violations of NRS 624.302(6) failure to comply with a written request from the Board for information or records; Two (2) violations of NRS 624.3011(1)(b)(1) willful or deliberate disregard and violation of the Building Laws of the State or of any political subdivision thereof; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.302(5) failure to cooperate in an investigation; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and monetary limit placed upon his license; NRS 624.3014(2)(a)(b)(c) aiding or abetting an unlicensed person to evade the provisions of this chapter; combining or conspiring with an unlicensed person to perform an unauthorized act; acting as agent, partner or associate of an unlicensed person; NRS 624.3011(1)(b)(4) willful or deliberate disregard and violation of the Laws of this State regarding Industrial Insurance; NRS 624.3016(7) misrepresentation or omission of a material fact or commission of any other fraudulent or deceitful act to obtain a license. Mr. McCormick was assessed a fine of \$500.00 for the First and Fifth Causes of Action, a fine of \$250.00 for the Third, Ninth and Tenth Causes of Action, a fine of \$100.00 for the Seventh Cause of Action and a fine of \$50.00 for the Second, Sixth and Eleventh Causes of Action for a total fine of \$2,000.00. Investigative costs were assessed in the amount of \$3,584.00. Mr. McCormick was ordered to pay restitution to Mr. Casas in the amount of \$5,000.00. Fines, costs and restitution to Mr. Casas are to be paid within 90 days from November 16, 2005 or license number 55659, T C M Construction Services, Inc., dba Cornerstone Roofing, Co. will automatically be Suspended. Mr. McCormick was ordered to either repair the roof on the Henry residence or pay restitution to Mr. Henry in the amount of \$6,800.00 within 90 days from November 16, 2005 or license number 55659, T C M Construction Services, Inc., dba Cornerstone Roofing, Co. will automatically be Suspended. Hearing Officer Filios ordered Counsel David Brown Esq. to provide a brief regarding the Twelfth, Thirteenth and Fourteenth Causes of Action by December 16, 2005. Counsel Evan James, Esq. is to respond by January 1, 2006. Reply to brief is due by January 11, 2006. The Hearing Officer will provide a written Decision and Order.

Hearing Officer Filios ordered a fine of \$2,250.00 for the Twelfth, Thirteenth and Fourteenth Causes of Action in lieu of Counsel providing a brief on the Twelfth, Thirteenth and Fourteenth Causes of Action to be paid within 90 days from November 17, 2005.

Bryan, dba Gerald Bryan Construction, license number 47543 guilty of violation of Two (2) violations of NRS 624.3017(1) substandard workmanship; Two (2) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.301(2) abandonment of a construction project when the percentage of the project completed is less than the percentage of the total price of the contract paid; Two (2) violations of NRS 624.302(5) failure to cooperate in an investigation; NRS 624.301(1) abandonment without legal excuse of any construction project engaged in or undertaken by the licensee; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with a written request from the Board for information or records; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and monetary limit placed upon his license; NRS 624.3012(2) failure to pay any money due for materials or services rendered when he has received sufficient money for the project. License number 47543, Gerald T. Bryan, dba Gerald Bryan Construction is Revoked. Mr. Bryan was assessed a fine of \$100.00 for the First, Second, Third, Fourth, Fifth, Sixth, Seventh, Eighth, Ninth, Tenth, Eleventh, Twelfth, Thirteenth and Fourteenth Causes of Action for a total fine of \$1,300.00. The Ninth and Fifteenth Causes of Action were dismissed. Investigative costs were assessed in the amount of \$4,052.00. Fines and costs are to be paid within 30 days from November 16, 2005. Mr. Bryan was ordered to pay restitution to Ying Pen Chen in the amount of \$7,131.36 within 30 days from November 16, 2005. Mr. Bryan was ordered to pay restitution to David Lowry in the amount of \$19,250.00 within 30 days from November 16, 2005. Mr. Bryan was ordered to pay restitution to Team Services in the amount of \$23,704.46 within 30 days from November 16, 2005.

Mr. Duff was found guilty of violation of NRS 624.305(1)(2) no license may be used by any person other than the person to whom such license is issued, no license may be assigned, transferred or disposed of; the license of any person who violates any provision of this section shall be automatically cancelled and revoked; NRS 624.3013(5), as set forth in NAC 624.650(1)(2) a licensee shall not permit his contracting business to be operated by an unlicensed person; except for corporate stockholders and a spouse's interest as community property a licensee shall not permit a person to have a proprietary interest in the contracting business unless that persons name appears on the license; NRS 624.3014(2)(a)(b)(c)(d) aiding or abetting an unlicensed person to evade the provisions of this chapter; combining or conspiring with an unlicensed person to perform an unauthorized act; allowing a license to be used by an unlicensed person and acting as agent, partner or associate of an unlicensed person. License number 17587, Sunrise Painting Company was Revoked. Mr. Duff is required to pay full restitution to the damaged parties and reimburse the Board for Investigative costs of \$1,484.00 and any expenses that may be paid out of the Residential Recovery Fund.
