The Respondent will be provided a billing and will reimburse the Board for the cost of the Business Review or reimburse the Board the investigative cost will result in the Suspension of the license.

Mr. Jensen was ordered to have a resolution to the water leak at the Wolpert residence within 30 days from December 14, 2005 or license number 20829, D. K. Jensen will automatically be Revoked. Mr. Jensen was ordered to furnish a current corporate financial statement prepared by a Certified Public Accountant within 30 days that supports Respondent's license limit or Respondent's monetary license limit will be reduced to \$850,000.00 and license number 20829, D. K. Jensen Construction, Inc. will automatically be Revoked.

Hearing Officer Scroggins found Respondent Construction Management Consultants, dba C M C Construction, Jon Van Vleck, President, license number 44571 guilty of Two (2) violations of NRS 624.302(5) failure to cooperate in an investigation; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with a written request from the Board for information or records; NRS 624.3013(5), as set forth NAC 624.640(3) failure to notify the Board of change of address or personnel within 30 days after the change occurs; Two (2) violations of NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3012(2) failure to pay money when due for materials or services rendered; NRS 624.3012(1) diversion of money received for the completion of a specific construction project; NRS 624.3013(4) failure to keep in force the bond or cash deposit for the full period required by the Board. Mr. Van Vleck was assessed a fine of \$100.00 for the Second, Third, Fourth, Fifth, Seventh, Eighth and Ninth Causes of Action for a total fine of \$700.00. The First and Sixth Causes of Action were dismissed. Investigative costs were assessed in the amount of \$1,365.00. Fines and costs are to be paid within 180 days from December 14, 2005 or license number 44571, Construction Management Consultants, dba C M C Construction will automatically be Revoked. Mr. Van Vieck was ordered to provide the Board with his current address of record.

Mr. Pierson is required to pay full restitution to the damaged parties and reimburse the Board for Investigative costs of \$1,470.00 and any expenses that may be paid out of the Residential Recovery Fund.
