Hearing Officer Wells found Respondent, Rags to Riches, Inc., Maria Angeles Hill, President, license number 48557, guilty of violation of NRS 624.3012(2) failure to pay; NRS 624.3012(1) diversion of money; NRS 624.302(5) failure to respond to written request from Board; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with written request from the Board; NRS 624.302(1)(b) contracting while license is inactive. Respondent was assessed a fine of \$1,000.00 for each of the First, Second and Sixth Causes of Action. Respondent was assessed a fine

Hearing Officer Wells found Respondent, Elegant Kitchen and Bath, Inc., Keith Dwayne Laudensack, President guilty of Two (2) violations of NRS 624.3017(1) substandard workmanship; Two (2) violations of NRS 624.3013(5) as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; Six (6) violations of NRS 624.301(4) failure to prosecute a construction project with reasonable diligence.; Two (2) violations of NRS 624.301(2) Abandonment of construction project when percentage completed is less than percentage of total contract paid; Seven (7) violations of NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to

owner; Two (2) violations of NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; Two (2) violations of NRS 624.301(5), failure to comply with the terms of the construction contract, thereby causing material injury to another; Three (3) violations of NRS 624.3013(5), as set forth in NRS 624.750(3)(a), unlawful to receive money for purpose of obtaining or paying for services, labor, materials or equipment if person willfully fails to use money to complete the improvements or failing to pay for any services, labor, materials or equipment provided for construction; NRS 624.3012(1) diversion of money; Seven (7) violations of NRS 624.302(5) failure to respond to written request from the Board; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6), failure to comply with a written request by Board; Three (3) violations of NRS 624.3013(5), as set forth in NRS 624.750(3)(a)(b) unlawful to receive money for purpose of obtaining or paying for services, labor, materials or equipment if person willfully fails to use money to complete the improvements or failing to pay for any services, labor, materials or equipment provided for construction and wrongfully diverts money to a use other than that for which it was received. Respondent was assessed a fine of \$1,000.00 for each of the first, Second, Third, Fourth, Seventh, Eighth, Ninth, Tenth, Thirteenth, Fifteenth, Sixteenth, Twentieth, Twenty Third, Twenty Fifth, Thirtieth and Thirty Fifth Causes of Action. Respondent was assessed a fine of \$500.00 for each of the Sixth, Twelfth, Fourteenth, Seventeenth, Nineteenth, Twenty First, Twenty Fourth, Twenty Sixth, Twenty Seventh, Twenty Ninth, Thirty First, Thirty Second, Thirty Fourth, Thirty Sixth, Thirty Seventh and Thirty Ninth Causes of Action. Respondent was assessed a fine of \$200.00 for each of the Fifth, Eleventh, Eighteenth, Twenty Second, Twenty Eighth, Thirty Third, and Thirty Eighth Causes of Action. Total fines assessed were \$25,400.00. The Respondent's license remains suspended. The Respondent cannot contract for any new business or use his license to sell materials while suspended. The investigative costs were assessed in the amount of \$5,884.00. Fines and costs are to be paid within 90 days of the May 24, 2006 Hearing or license number 59210, Elegant Kitchen and Bath, Inc. will be revoked. Mr. Laudensack was ordered to make restitution to Strasser in the amount of \$61,741.09; to Parise in the amount of \$20,386.50; to McCormick in the amount of \$12,338.22; to Oswald in the amount of \$12,486.00; to Leavitt in the amount of \$12,343.77; to Ramos in the amount of \$65,904.93; to Gieseking in the amount of \$47,133.17 and to Ball in the amount of \$26,711.86 within ninety (90) days of the May 24, 2006 hearing or license number 59210, Elegant Kitchen and Bath, Inc. will be revoked.
