of the contract; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3011(1)(b)(1) failure to comply with the building laws of the state; NRS 624.3013(3) failure to establish financial responsibility. License number 53665, Vincent Salvator Carlese, Owner dba Vincent S. Carlese Builder is Revoked. Mr. Carlese was ordered to pay a fine of \$1,000.00 each for the First, Second, Fourth, Fifth, Sixth, Seventh and Eighth Causes of Action and a \$100.00 fine for the Third Cause of Action for a total amount of \$7,100.00; pay full restitution to the damaged parties; and reimburse the Board for Investigative costs of \$1,812.00 and any claims and associated expenses that may be paid out of the Residential Recovery Fund.

The First, Second, Third, Sixth and Ninth Causes of Action were dismissed. a contractor; NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; NRS 624.3011(1)(b)(1) failure to comply with the building laws of the state; NRS 624.301(5) willful failure or refusal to comply with terms of a construction contract or written warranty thereby causing material injury to another; NRS 624.3014(2)(a-d) Aiding or abetting an unlicensed person; NRS 624.3015(3) knowingly entering into a contract with a contractor while that contractor is not licensed; NRS 624.3013(3) failure to establish financial responsibility. License number 53260 is Revoked. Respondent shall pay full restitution to the damaged parties and reimburse the Board for investigative costs of \$1,910.00 and any claims and associated expenses that may be paid out of the Residential Recovery Fund.
