Hearing Officer Wells found Respondent Lewis Andrew Eddings, dba Eddings Commercial Contractors, license number 32018 quilty of two (2) violations of NRS 624.3012(2) failure to pay money when due; Three (3) violations of NRS 624.302(5) failure to respond to a written request by the Board; Three (3) violations of NRS 624.3013(5), as set forth in NAC624.640(5) failure to include license number and monetary license limit on contracts; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with written request by the Board; NRS 624.3013(4) failure to keep in force bond for full period required by Board. Hearing Officer Wells found Respondent Progressive Landscaping, Daryl Curtis Byerly, President, license number 56879 guilty of violation of NRS 624.3012(2) failure to pay money when due; NRS 624.3012(1) diversion of money; Four (4) violations of NRS 624.302(5) failure to respond to a written request by the Board; Three (3) violations of NRS 624.3017(1) substandard workmanship; Three (3) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(6) failure to comply with written request by the Board; NRS 624.3013(4) failure to keep in force bond for full period required by Board; NRS 624.301(4) failure to prosecute a construction project with reasonable diligence; NRS 624.3013(5), as set forth in NRS 624.300 failure to comply with an order directed by the Board. The Second Cause of Action was dismissed.
