Licensee was ordered to pay a fine of \$500.00 each for the First, Second, Third, Fifth and Sixth Causes of Action; \$200.00 for the Fourth Cause of Action for a total fine of \$2,700.00; reimburse the Board's investigative fees and costs in the amount of \$2,294.00; complete the repairs to the Schilling and Woods residence; provide 24 to 48 hours notice to make repairs and provide a person to communicate between workers and homeowners within 45 days of December 7, 2006 or license number 55592 will be automatically suspended. Licensee shall complete the concrete repairs to the Woods residence by May 1, 2007 or license number will be automatically be suspended. Licensee was ordered to furnish a CPA prepared financial statement to the Board within 60 days of December 7, 2006 or license number 55592 will be automatically suspended.
