Hearing Officer Higgins found Respondent Ronnie Dale Swope, Owner dba R D Swope Construction, license numbers 44170, 57123, 57124, 57255 guilty of violating NRS 624.3011(1)(a) disregard of plans and specifications; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner. Mr. Swope was ordered to pay a fine of \$1,000.00 for the First Cause of Action; \$250.00 for the Second Cause of Action and \$100.00 for the Third Cause of Action for a total fine of \$1,350.00 and assessed investigative costs in

the amount of \$2,248.00. The Fourth Cause of Action was dismissed, however, Licensee has 30 days from April 11, 2007 to provide current accounts receivable and bank statements to the Board or the Fourth Cause of Action will be reinstated. Fines and costs to be paid within 90 days of April 11, 2007 or license numbers 44170, 57123, 57124 and 57255 will be automatically suspended.

# 2. DISCIPLINARY HEARING: EAST SLOPE BUILDERS, LICENSE NO. 38737

Hearing Officer Higgins found Respondent Ronald George Soliday, Owner dba East Slope Builders, license number 38737 guilty of violating NRS 624.3012(3) failure to obtain the discharge of Lien; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.3016(6) failure to comply with NRS 624.600 which requires disclosures by general building contractors. Mr. Soliday was ordered to pay a fine of \$100.00 for the Second Cause of Action and \$250.00 for the Third Cause of Action for a total fine of \$350.00; and assessed investigative costs in the amount of \$1,480.00. No fines were assessed for the First Cause of Action however, if the Licensee does not remove the \$16,994.00 lien from Radtke Tile by April 30, 2007, license number 38737 will be automatically revoked. The Fourth Cause of Action was dismissed. Fines and costs to be paid within 60 days of April 11, 2007 or license number 38737 will be automatically suspended.

Hearing Officer Higgins found Respondent Cindy Dennis President of Deblor Corporation, license number 60452 guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.3016(6) failure to comply with NRS 624.600 which requires disclosures by general building contractors. Ms. Dennis was ordered to pay a fine of \$1,000.00 for the First Cause of Action; \$250.00 for the Second Cause of Action; \$100.00 for the Third Cause of Action and \$250.00 for the Fourth Cause of Action for a total fine of \$1,600.00; and assessed investigative costs in the amount of \$1,952.00. Fines and costs to be paid within 60 days of April 11, 2007 or license number 60452 will be automatically suspended.

License number 61661 was Revoked. Respondent shall pay full restitution to the damaged homeowners; pay a fine in the amount of \$2,850.00; reimburse the Board for investigative costs of \$1,763.00 and any claims and associated expenses that may be paid out of the Residential Recovery Fund.
