Mr. McCatheran was found guilty of two (2) violations of NRS 624.301(1) abandonment of any construction project or operation engaged in or undertaken by the licensee as a contractor; two (2) violations of NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund notice to owner; two (2) violations of NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this state, the number of his license and monetary limit placed upon his license; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; one (1) violation of NRS 624.302(5) failure to respond to a written request from the Board to cooperate in the investigation of a complaint; one (1) violation of NRS 624.3013(4) failure to keep in force the bond or cash deposit for the full period required by the Board; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. License number 63695, McCatheran Construction Inc., was revoked. Mr. McCatheran was assessed a fine of \$5,700.00. Investigative costs were assessed in the amount of \$2,008.00. Mr. McCatheran is required to pay full restitution to all damaged parties and reimburse the Board for any monies paid out of Residential Recovery fund plus fines and investigative costs prior to consideration of future licensure.

b. H. S. L. CORP., dba B J's GLASS N MIRROR CO., LICENSE NO. 52988

License number 52988, H. S. L. Corp., dba B J's Glass N Mirror Co., was revoked. Mr. Reiff was assessed a fine of \$3,700.00. Investigative costs were assessed in the amount of \$1,231.00. Restitution was ordered to New World West, Inc., in the amount of \$9,391.64, to Linda Brown in the amount of \$315.00 and to Stanley Jones in the amount of \$121.00. Mr. Reiff is required to pay full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery fund plus fines and investigative costs prior to consideration of future licensure.

Mr. Lynn was found guilty of one (1) violation of NRS 624.301(5) willful failure and refusal to comply with the terms of a construction contract; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; one (1) violation of NRS 624.301(4) willful failure or refusal to prosecute a construction project or operation with reasonable diligence; two (2) violations of NRS 624.301(1) abandonment of construction project or operation engaged in or undertaken by the licensee as a contractor; two (2) violations of NRS 624.3012(1) diversion of money; one (1) violation of NRS 624.3011(1)(b)(1) willful or deliberate disregard and violation of the building laws of the State; one (1) violation of NRS 624.302(5) failure or refusal to respond to a written request from the Board to cooperate in the investigation of a complaint; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this state, the number of his license and monetary limit placed upon his license; one (1) violation of NRS 624.3011(1)(b)(2) willful or deliberate disregard and violation of the safety laws or labor laws of the State; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(3) failure to notify Board within 30 days of change of address. License number 51227, Silver Express, Inc., dba Silver Express Construction, was revoked. Mr. Lynn was assessed a fine of \$8,500.00. Investigative costs were assessed in the amount of \$2,350.00. Mr. Lynn is required to pay full restitution to all damaged parties and reimburse the Board for monies paid out of the Residential Recovery fund plus fines and investigative costs prior to consideration of future licensure.
