Hearing Officer Higgins found Respondent Pentagon Plumbing and Air Conditioning, license number 58722 guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(3) failure to establish financial responsibility. Mike Stokely, President of Pentagon Plumbing and Air Conditioning, was ordered to pay a fine of \$2,000.00 for the First Cause of Action and \$2,000.00 for the Third Cause of Action; reimburse the Board for investigative costs of \$2,016.00. Hearing Officer Higgins accepted a monetary settlement agreement between the Respondent, Herbst Station Repair Inc., license number 13211A and the complainant, Robert DeYoe. Settlement terms consist of DeYoe making a \$30,000.00 payment to the Respondent for which the Respondent will drop a civil complaint in Nye County District Court and release any liens against DeYoe's property. Furthermore, the Respondent was ordered to provide the Board with a personal financial statement within sixty (60) days. Further action on this complaint will be held in abeyance by the Board until such time as this agreement has been fulfilled and the Respondent has submitted the required financial statement. At such time the settlement agreement is fulfilled and the Respondent complies with the order of the Board, this complaint will be dismissed.

Hearing Officer Higgins found Respondent Sean Joseph Channey, Owner dba Creative Land Concepts, license number 54143 in default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. Licensee was found guilty of violating NRS 624.301(3) willful failure in a material respect on the part of a licensee to complete any construction project; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.301(1) abandonment without legal excuse of any construction project or operation engaged in or undertaken by the licensee as a contractor; NRS 624.301(2) abandonment of a construction project when the percentage of the project completed in less than the percentage of the total price of the contract paid; NRS 624.302(5) failure or refusal to cooperate in an investigation; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.3013(3) failure to establish financial responsibility. License number 54143 was Revoked. Respondent shall pay full restitution to the damaged party; pay a fine in the amount of \$4,350.00; reimburse the Board for investigative costs of \$1,956.00 and any claims and associated expenses that may be paid out of the Residential Recovery Fund.

# <u>4. DISCIPLINARY HEARING:</u> SILVER MEADOWS LANDSCAPING, LLC, LICENSE NOS. 57801 AND 62770

Licensee was found guilty of violating NRS 624.3012(2) failure to pay for materials and services; NRS 624.3016(1) fraudulent or deceitful act; NRS 624.3018(2) association of any act or omission constituting a cause for disciplinary action and NRS 624.3013(3) failure to establish financial responsibility. License numbers 57801 and 62770 are Revoked. Respondent shall pay full restitution in the amount of \$11,054.05 to the damaged party; pay a fine in the amount of \$2,250.00; reimburse the Board for investigative costs of \$1,697.00 and any claims and associated expenses that may be paid out of the Residential Recovery Fund.
