Hearing Officer Efstratis found Robert Paul Stinnett, Owner dba Stinnett Construction, license number 49244 guilty of violating NRS 624.3017(1), substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.3016(6) failure to comply with NRS 624.600 which requires disclosures by general building contractors; NRS 624.3013(4) failure to keep in full force the bond or cash deposit pursuant to NRS 624.270 for the full period required by the Board; NRS 624.3013(3) failure to establish financial responsibility. License number 49244 is suspended. The monetary license limit was reduced to \$800,000.00 and the bond to \$20,000.00.
