Hearing Officer King found Respondent Sierra Custom Concrete, LLC, license number 67736 and Sierra Poolscapes, license number 70401 guilty of violating NRS 624.3017(1) by failing to provide workmanship which is commensurate with the standards of the trade in general; NRS 624.3013(5) by failing to comply with the Board's Notices to Correct pursuant to NAC 624.700(3); NRS 624.3018(2), which states in pertinent part that the performance by any partnership, corporation, firm or association of any act or omission constituting a cause for disciplinary action likewise constitutes a disciplinary action against any licensee who is a member, officer, director or associate of such partnership, corporation, firm or association, and who participated in such prohibited act or omission; NRS 624.3013(5) by failing to notify the owner of their rights related to the recovery fund pursuant to NRS 624.520(1); NRS 624.3014(2)(a) & (b), by: (a) Aiding or abetting an unlicensed person to evade the provisions of this chapter; (b) Combining or conspiring with an unlicensed person to perform an unauthorized act; NRS 624.3016(5) by failing to comply with NRS

Respondent was ordered to pay to the homeowner \$500.00 for the pool cover, properly install the skimmer and completed all repairs on Notice to Correct and Amended Notice to Correct within thirty (30) days, with the exception of item #1 on the Amended Notice to Correct. If the spa is not repaired or the homeowner not reimbursed for the repairs within thirty (30) days, the license will be suspended.

Hearing Officer King found Respondent Sierra General Contractors, license numbers 40928, 40928A and 40928B guilty of violating NRS 624.3012(2), by willfully or deliberately failing to pay any money when due for any materials or services rendered in connection with his operations as a contractor, when he has the capacity to pay or when he has received sufficient money therefore; NRS 624.3013(4) by failing to keep in force the bond or cash deposit pursuant to NRS 624.270 for the full period required by the Board; NRS 624.3018(2), which states in pertinent part that the performance by any partnership, corporation, firm or association of any act or omission constituting a cause for disciplinary action likewise constitutes a cause for disciplinary action against any licensee who is a member, officer, director or associate of such partnership,

corporation, firm or association, and who participated in such prohibited act or omission; NRS 624.3012(2) failure to pay for materials and services and NRS 624.3013(3) failure to establish financial responsibility. Hearing Officer King ordered the revocation of license numbers 40928, 40928A and 40928B. No fines or investigative costs were assessed.

# 7. DISCIPLINARY HEARING: DEFAULT ORDER J W SMITH CONSTRUCTION, LLC, LICENSE NO. 59312

Licensee was not present.

Licensee was found guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.301(1) abandonment without legal excuse of any construction project or operation engaged in or undertaken by the licensee as a contractor; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3016(6) failure to comply with NRS 624.600 which requires disclosures by general building contractors; NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license: NRS 624.3012(2) failure to pay for materials and services; NRS 624.302(5) failure or refusal to cooperate in an investigation; NRS 624.302(6) failure or refusal to comply with a written request by the Board for information or records; NRS 624.3012(2) failure to pay for materials and services; NRS 624.3013(3) failure to establish financial responsibility. Hearing Officer King ordered the revocation of license number 59312. Respondent was ordered to pay a fine in the amount of \$9,600.00; reimburse the Board for investigative costs of \$2,909.00; pay restitution to any damaged parties and any claims and associated expenses that may be paid out of the Residential Recovery Fund.
