Respondent was ordered to pay full restitution to the damaged parties and reimburse the Board for any monies paid out of the Residential Recovery fund plus fines and investigative costs prior to consideration of future licensure.

I. 702 SERVICES, LICENSE NO 60254

Licensee was not present.

Hearing Officer King found Respondent 702 Services, license number 60254, Jodi Lyn Tuttle, President, in default and adopted the Findings of Fact and Conclusion of Law as set forth in the Administrative complaint. Ms. Tuttle was found guilty of one (1) violation of NRS 624.302(5) failure to

respond to a written request from the Board; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. Respondent was assessed a fine of \$1,000.00 and investigative costs in the amount of \$1,495.00. License number 60254, 702 Services, was revoked. Respondent was ordered to pay full restitution to the damaged parties and reimburse the Board for any monies paid out of the Residential Recovery fund plus fines and investigative costs prior to consideration of future licensure.
