Hearing Officer Hodgson found Respondent guilty of one (1) violation of NRS 624.3017(1) substandard workmanship; one (1) violation of NRS 624-3013(5), as set forth in NAC 624.700(3(a) failure to comply with Board's Notice to Correct; one (1) violation of NRS 624.3011(1)(a) willful disregard of plans or specifications without the consent of the owner; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5); one (1) violation of NRS 624.3013(3) failure to establish financial responsibility.
