Hearing Officer Wells found Respondent Crest Heights Company of Nevada dba, Bailey Construction, license number 3417A guilty of violating NRS 624.3016(1) fraudulent or deceitful act; NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; NRS 624.3015(4) knowingly entering into a contract with a contractor while that contractor is not licensed; NRS 624.3014(2)(a-d) Aiding or abetting an unlicensed person and NRS 624.3013(3) failure to establish financial responsibility. Hearing Officer Wells ordered the Respondent to pay a fine of \$1,000.00 each for the First, Second, Third, Fourth and Fifth Causes of Action and a \$500.00 fine for the Sixth Cause of Action for a total fine of \$5,500.00; reimburse the Board for investigative costs in the amount of \$3,764.00 within thirty (30) days from October 6, 2010 or license number 3417A will automatically be revoked. Hearing Officer Wells ordered Respondent's monetary license limit be reduced to \$1,000,000.00; ordered Respondent to provide a current financial statement that supports the lowered monetary license limit within thirty (30) days from October 6, 2010 or license number 3417A will automatically be revoked.
