Hearing Officer Drake found the Respondent U C Unlimited Construction Inc, license number 52742 and U C Unlimited Construction Inc dba, Unlimited Seamless Rain Gutters, license number 62131 in default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. Licensee was found guilty of violating NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license and NRS 624.3013(3) failure to establish financial responsibility. License number 67192 was revoked. Respondent shall pay an administrative fine of \$2,000.00 for the First Cause of Action, \$1,000.00 for the Second Cause of Action, \$50.00 for the Third Cause of Action, \$1,000.00 for the Fourth Cause of Action and \$500.00 for the Fifth Cause of Action for a total fine of \$4,550.00 and investigative costs of \$2,117.00.

8. FINANCIAL RESPONSIBILITY HEARING: TAYLOR REFRIGERATION & HVAC, LICENSE NO. 57909

Licensee was present.

This matter was continued for thirty (30) days.

9. FINANCIAL RESPONSIBILITY HEARING: HERBERT ALESSANDRO MELENDES dba, MINI DISH SATELLLITE SERVICES, LICENSE NO. 74806
