Exhibit B – Respondent submitted a packet of documents which included, among other items, a copy of the electrical and plumbing subcontracts for the Perry Street project.

Hearing Officer Hodgson found Respondent guilty of one (1) violation of NRS 624.301(1) abandonment of construction project; one (1) violation of NRS 624.301(4) failure to prosecute a construction project with reasonable diligence; one (1) violation of NRS 624.301(5) failure to comply with the terms of the construction contract, thereby causing material injury to another; one (1) violation of NRS 624.3013(4) failure to keep bond in force; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; one (1) violation of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or partner of licensee. Respondent was assessed a fine of \$1,000.00 for each of the First, Second and Third Causes of Action; a fine of \$250.00 for the Fourth Cause of Action; a fine of \$500.00 for the Fifth Cause of Action for total fines of \$3,750.00 and investigative costs of \$4,571.00. Fines and costs are due within thirty (30) days of the August 15, 2011 hearing or license numbers 67984, 52522A, 69383 are revoked. If Avery Atlantic, LLC timely pays the fines and costs, the Board shall accept the voluntary surrender of license numbers 67984, 52522A and 68383. If Avery Atlantic fails to timely pay the fines and costs, Faith Vision, Inc., dba Faith Builders, license number 74754 shall have thirty (30) days to remove and replace Charles Norton Slayton as the Qualified Individual or license number 74754 shall be suspended until such removal and replacement takes place. If Avery Atlantic, LLC fails to timely pay the fines and costs, Sol Up USA, LLC, license number 75025 shall have thirty (30) days to remove and replace Charles Norton Slayton as the Member and Qualified Individual or license number 75025 shall be suspended until such removal and replacement takes place.
