Administrative Law Judge Andrews found Respondent guilty of one (1) violation of NRS 624.302(5) failure to comply with a written request from the Board. Respondent was assessed a fine of \$250.00 for the Second Cause of Action and investigative costs of \$1,656.00. The First and Third Causes of Action were dismissed. The fines and investigative costs are due within thirty (30) days of the December 19, 2012 hearing or license number 73582, Proficient Stone Manufacturing, Inc. shall be revoked. If Respondent timely pays the fines and investigative costs, the Board shall accept the voluntary surrender of license number 73582, Proficient Stone Manufacturing, Inc.

Licensee was present but not represented by counsel at the hearing.

Administrative Law Judge Andrews found Respondent guilty of one (1) violation of NRS 624.3013(5) failing to comply with the regulations of the Board and one (1) violation of NRS 624.302(1)(a) contracting while the license has been suspended. Respondent was assessed a fine of \$250.00 each for the First and Second Causes of Action for total fines of \$500.00 and investigative costs of \$1,404.00. The Third and Fourth Causes of Action were dismissed. The fines and investigative costs are due within thirty (30) days of the December 19, 2012 hearing or license number 75396, Construction Services & Solutions, LLC shall be revoked. If Respondent timely pays the fines and investigative costs, the Board shall accept the voluntary surrender of license number 75396, Construction Services & Solutions, LLC.

<u>b. DONALD ALLEN FOSTER, JR., OWNER, dba SONORA AIR CONDITIOING & REFRIGERATION,</u> License No. 44060

Licensee was not present nor represented by counsel at the hearing.

Administrative Law Judge Andrews found Respondent Donald Allen Foster, Jr., Owner, dba Sonora Air Conditioning & Refrigeration, license number 44060 in default and adopted the Findings of Fact and Conclusion of Law as set forth in the Administrative complaint. The Respondent was found guilty of one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; one (1) violation of NRS 624.302(5) failing to respond to a written request from the Board. Respondent was assessed a fine of \$500.00 for the First Cause of Action and a fine of \$250.00 for the Second Cause of Action for total fines of \$750.00 and investigative costs of \$1,590.00. License number 44060, Donald Allen Foster, Jr., Owner, dba Sonora Air Conditioning & Refrigeration was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.

Administrative Law Judge Andrews found Respondent R. C. B. B., Inc., license numbers 10015A, 73148 and 75034 in default and adopted the Findings of Fact and Conclusion of Law as set forth in the Administrative complaint. The Respondent was found guilty of one (1) violation of NRS 624.3015(5)(a) repairing a mobile home or manufactured home without being properly licensed; one (1) violation of NRS 624.302(5) failing to respond to a written request from the Board; one (1) violation of NRS 624.3011(1)(b)(4) violation of the laws of this State regarding industrial insurance; one (1) violation of

NRS 624.302(6) failing to comply with a written request from the Board; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(3) failure to notify the Board of a change of address; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; one (1) violation of NRS 624.302(5) failure to respond to a written request from the Board; one (1) violation of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or partner of licensee. Respondent was assessed a fine of \$500.00 each for the First, Third, Fourth and Sixth Causes of Action; a fine of \$250.00 each for the Second, Fifth and Seventh Causes of Action for total fines of \$2,750.00 and investigative costs of \$1,751.00. License numbers 10015A, 73148 and 75034, R. C. B. B., Inc. were revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.
