Respondent was assessed a fine of \$1,000.00 each for the First and Third Causes of Action; a fine of \$500.00 each for the Second, Seventh, Eighth, Eleventh, Twelfth and Thirteenth Causes of Action; a fine of \$250.00 each for the Fourth, Sixth, Ninth and Tenth Causes of Action; a fine of \$100.00 for the Fifth Cause of Action for total fines of \$6,100.00 and investigative costs of \$1,949.00. License number 53269, Timothy Allen Janusz, Owner, dba Timberwolf Cabinetry & Millwork was revoked.
