Hearing Officer Leggett found the Respondent Heartwood Homes LLC, license number 77237 guilty of violating NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; NRS 624.3016(1) fraudulent or deceitful act; NRS 624.301(3) in a material respect on the part of a licensee to complete any construction project; NRS 624.301(5) willful failure or refusal to comply with terms of a construction contract or written warranty thereby causing material injury to another; NRS 624.3012(2) failure to pay for materials and services and NRS 624.3013(3) failure to establish financial responsibility. Mr. Hessing shall pay an administrative fine of \$750.00 for the First Cause of Action, \$750.00 for the Second Cause of Action, \$1,000.00 for the Third Cause of Action; \$1,000.00 for the Fourth Cause, dismiss the Fifth Cause of Action and no fine for the Sixth Cause of action for a total fine of \$3,500.00; reimburse the Board for investigative fees of \$1,696.00 to be paid within thirty (30) days. If the fines and fees are paid within the thirty days, the suspension shall be lifted. The monetary license limit is reduced to \$200,000.00.

4. FINANCIAL RESPONSIBILITY HEARING:

PFCINC, LICENSE NO. 61025 Licensee was present.

Hearing Officer Leggett ordered the Respondent to pay investigative costs in the amount of \$468.78; provide a properly prepared financial statement supporting the license limit and update its officers with the Nevada Secretary of State.
