Hearing Officer Leggett found Respondent found Judson Enterprises Inc dba, K Designers, license numbers 38900, 71229, 73114 and 73293 guilty of violating NRS 624.3013(3) failure to establish financial responsibility. K Designers shall pay a fine of \$500.00 for the First Cause of Action; reimburse the Board investigative fees of \$1,520.00; fines and fees are to be paid within thirty (30) days of November 6, 2013 or licenses will automatically be revoked. Respondent shall provide a current financial statement within thirty (30) days of November 6, 2013 or licenses will automatically be revoked. The monetary license limits on all licenses has been reduced to \$45,000.00.

2. FINANCIAL RESPONSIBILITY HEARING:

Hearing Officer Leggett found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(5) failure to comply with written request of the Board. No administrative fines were imposed. Prior to reactivation Respondent must provide a properly completed indemnification agreement and pay investigative fees in the amount of \$469.66.

4. FINANCIAL RESPONSIBILITY HEARING: PRIDE PRINTING LLC, LICENSE NO. 76896

Licensee was present.

Hearing Officer Leggett found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(5) failure to comply with written request of the Board. License is suspended. Respondent must pay a fine of \$750.00 and investigative fees in the amount of \$472.16; must reinstate entity with the Secretary of State; provide a current financial statement, including derogatory credit information, if any, within thirty (30) days or the license will be revoked.

5. FINANCIAL RESPONSIBILITY HEARING: LYONS ELEVATOR SERVICES LLC, LICENSE NO. 77148

Licensee was not present.

Hearing Officer Leggett found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(5) failure to comply with written request of the Board and NRS 624.3013(4) failure to keep in full force the bond or cash deposit pursuant to NRS 624.270 for the full period required by the Board. Respondent must pay a fine of \$1,000.00 and investigative fees in the amount of \$470.91. License number 77148 is revoked.

Hearing Officer Leggett found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility; NRS 624.302(5) failure to comply with written request of the Board.
