The agenda was posted in compliance with the open meeting law **JANUARY 3**, **2013** at Reno City Hall, Washoe County Court House and Washoe County Library. The agenda was also posted in both offices of the Board, Henderson and Reno and on the Board Internet Website.

ADMINISTRATIVE LAW JUDGE: DAVID BROWN

1. FINANCIAL RESPONSBILITY HEARING: FAILURE TO COMPLY WITH D & O ITAL STONE INC, LICENSE NOS. 53369 & 58861

Licensee was present.

Administrative Law Judge Brown ordered the suspension of license numbers 53369 and 58861 until the Respondent provides a surety bond and financial statement supporting some level of license limit which may be adjusted based upon what limit is supported. Upon receipt of a positive financial statement and bond, the suspension shall be lifted.

2. FINANCIAL RESPONSIBILITY HEARING: ASHTON CONSTRUCTION INC, LICENSE NO. 76470

Licensee was not present.

Administrative Law Judge Brown ordered the suspension of license number 76470 and authorized staff to make a determination regarding approval of the inactive application received on January 8, 2013.

3. FINANCIAL RESPONSIBILITY HEARING:

JEFFREY DAVID STAPLETON DBA SHINING KNIGHT ELECTRICAL SERVICES, LICENSE NO. 70519A

Licensee was present.

Administrative Law Judge Brown ordered the suspension of license number 70509A. Respondent was found guilty of violating NRS 624.3013(3) failure to establish financial responsibility. The charge of failure to comply with the Board was dismissed. Respondent must pay a fine of \$500.00 and investigative fees in the amount of \$467.53. A current financial statement supporting the license limit is due within thirty (30) days or the license remains suspended. The suspension may be lifted if a satisfactory financial statement is provided prior to the 30 day deadline.

4. NEW APPLICATION DENIAL HEARING: A CUT ABOVE CARPENTRY

Licensee was present.

Administrative Law Judge Brown continued this matter to allow the Respondent to provide additional operating capital to support the requested monetary license limit. Mr. Brown authorized staff to approve the application if the financial information supports the requested license limit.

5. NEW APPLICATION DENIAL HEARING: MAGRATH VENTURES LLC DBA THE GLASS GURU OF CARSON CITY

Licensee was present.

Administrative Law Judge Brown approved the license with a \$50,000.00 monetary license limit and a \$5,000.00 bond.

6. NEW APPLICATION DENIAL HEARING: STATELINE MECHANICAL

Licensee was present.

Administrative Law Judge Brown continued this matter for thirty (30) days to allow Mr. Wieand to provide an indemnification agreement and corresponding financial information, if he chooses to indemnify the application.

7. NEW APPLICATION DENIAL HEARING: CONTINUED FROM DECEMBER 5, 2012 REFRIGERATION SYSTEMS CONSTRUCTION & SERVICES INC

Licensee was present.

Administrative Law Judge Brown approved the license with a \$249,000.00 monetary license limit and a \$15,000.00 bond with a one (1) year business review, which shall include the names of all employees working in Nevada and any new criminal history since licensure.

8. NEW APPLICATION DENIAL HEARING: CONTINUED FROM NOVEMBER 7, 2012 M S L DEVELOPMENT LLC

Licensee was present.

Administrative Law Judge Brown approved the license with a \$5,000,000.00 monetary license limit with a \$350,000.00 bond and a financial review for the first two years of licensure. Respondent is authorized to only self-perform construction and not contract any third party work.

There being no further business to come before the Board, the meeting was adjourned by Administrative Law Judge David Brown at 12:45 p.m.
