Hearing Officer Cavin found the Respondent Patrick Ishmael Gorman dba, ABC Road Builders, license number 75110 guilty of twice (2) violating NRS 624.3015 (2) which states: "Bidding to contract or contracting for a sum for one construction contract or project in excess of the limit placed on the license by the Board; three times (3) violating NRS 624.520 (1) which states: "A residential contractor shall notify an owner with whom he or she contracts of the rights of the owner pursuant to NRS 624.400 to 624.560, inclusive, including, without limitation, providing a written statement explaining those rights in any agreement or contract for qualified services; twice (2) violated NRS 624.720 (3) which states: "All advertising by a licensed contractor must include the name of the contractor's company and the number of the contractor's license; twice (2) violating NRS 624.3013 (5) and NAC 624.640 (5) which states: "Each Licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; twice (2) violating NRS 624.3014 (a) which states: "Aiding or abetting an unlicensed person to evade the provision of this chapter; twice (2) violating NRS 624.302 (5) which states: "Failure or refusal to respond to a written request from the Board or its designee to cooperate in the investigation of a complaint; NRS 624.301(1) by abandoning without legal excuse of any construction project or operation engaged in or undertaken by the licensee as a contractor; NRS 624.3013(5) by failing to comply with the Board's Notices to Correct pursuant to NAC 624.700(3)(a);NRS 624.302(5) by failing or refusing to respond to a written request from the Board or its designee to cooperate in the investigation of a complaint;NRS 624.302(6) by failing or refusing to comply with a written request by the Board for records, or obstructing or delaying and providing information; NRS 624.3013(3) by failing to establish financial responsibility pursuant to NRS 624.220 and 624.260 to 624.265, inclusive, at the time of renewal of the license or at any other time when required by the Board. License 75110 shall remain suspended for a period of six (6) months. Mr. Gorman shall pay an administrative fine of \$500.00 for the First Cause of Action, \$750.00 for the Second Cause of Action, \$1,000.00 for the Third Cause of Action; \$250.00 for the Fourth Cause of Action; \$1,000.00 for the Fifth Cause of Action; \$250.00 for the Sixth Cause of Action; \$1,000.00 for the Seventh Cause of Action; \$500.00 for the Eighth Cause of Action; \$250.00 for the Ninth Cause of Action; \$250.00 for the Tenth Cause of Action and \$500.00 for the Eleventh Cause of Action for a total fine of \$6,250.00; reimburse the Board for investigative fees of \$3,118.00; reimburse Ms. Wells \$6,000.00 and provide a current financial statement to the Board within forty-five (45) days of July 10, 2013 or license number 75110 will automatically be revoked.

License number 23042 is revoked.
