ALJ Allison found the Respondent in violation of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(6) failure to comply with a written request by the Board. Respondent was fined \$500.00 for each of the First and Second Causes of Action for total fines of \$1,000.00 and investigative costs of \$467.31. License number 81382, Malleum, LLC was revoked.

5. FINANCIAL RESPONSIBILITY HEARING:

REBEL STONE & TILE, License No. 81605

Licensee was present.

ALJ Allison suspended license number 81605, Rebel Stone & Tile until a current compliant financial statement that supports the license limit is provided to the Board. The Respondent was ordered to pay investigative costs of \$463.23 within thirty (30) days of the January 3, 2018 hearing. If Respondent fails to provide a compliant financial statement, bank verification form and pay the costs within thirty (30) days, the matter will be heard again on March 7, 2018.
