ALJ Georgeson dismissed the Board's Complaint against Nevada Delta Mechanical, Inc., license number 72999 and Delta Mechanical, Inc., license numbers 53330, 75345 and 80398.

GUADALUPE YANETH CASTANEDA, OWNER, dba RAINBOW POOL PLASTERING, License No. 74187

Licensee was present and represented by Tony May, Esq. at the hearing.

ALJ Georgeson found Respondent guilty one (1) violation of NRS 624.3017(1) workmanship not commensurate with the standards of the trade in general; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; and one (1) violation of NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license. The Fourth Cause of Action was dismissed. Respondent was assessed a fine of \$1,000.00 for the First Cause of Action; a fine of \$500.00 for the Second Cause of Action; a fine of \$2,500.00 for the Third Cause of Action for total fines of \$4,000.00 and investigative costs of \$2,251.00. Fines and costs are to be paid within sixty (60) days of the May 2, 2018 hearing. Christine Kendzora, homeowner shall obtain three (3) bids from properly licensed contractors to make the necessary repairs to the pool plastering and the pool decking. Upon obtaining the three (3) bids, Ms. Kendzora shall submit the bids to the Board. The Board shall notify the Respondent in writing of the bids and require the Respondent to make payment to Ms. Kendzora within sixty (60) days of such notification in the amount of the lowest bid. If Respondent fails to submit payment to Ms. Kendzora within such sixty (60) day period, the Board may take necessary action to suspend or revoke the license. License number 74187 was placed on Probation. As a condition of Probation, at six (6) month intervals, beginning six (6) months and continuing for two (2) years from the date of the Decision and Order, Respondent shall submit to the Board copies of all contracts entered into during the applicable six-month period. If any contract demonstrates a violation of applicable law, Respondent's license shall be immediately suspended and the Board may take any lawful action with regard to the license. Respondent shall pay the Board for any costs incurred in each review up to \$500.00 each review period within thirty (30) days.
