ALJ Allison found Respondent Home Masters guilty of one (1) violation of NRS 624.3016(5), as set forth in NRS 624.600(1)(a)(b) failure to provide the required notices; ten (10) violations of NRS 624.301(5) failure to comply with the terms of a construction contract or written warranty; seven (7) violations of NRS 624.3013(5), as set forth in NAC 624.750(4)(b) diversion of money; ten (10) violations of NRS 624.302(6) failure to comply with a written request by the Board; two (2) violations of NRS 624.3017(1) workmanship not commensurate with the standards of the trade in general; two (2) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; three (3) violations of NRS 624.301(1) abandonment of any construction project by the licensee as a contractor; three (3) violations of NRS 624.301(2) abandonment of a construction project when the percentage of the project completed is less than the percentage of the total price of the contract paid to the contractor at the time of abandonment; one (1) violation of NRS 624.302(5) failure to respond to a written request from the Board; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; and two (2) violations of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or

partner of licensee. Respondent Home Masters was assessed a fine of \$1,000.00 for each of the First, Fourth and Seventh Causes of Action; a fine of \$5,000.00 for each of the Second, Fifth, Twenty-Second, Twenty-Third, Twenty-Fifth, Twenty-Sixth, Thirtieth, Thirty-First, Thirty-Second, Thirty-Fourth, Thirty-Fifth, Thirty-Seventh and Thirty-Eighth Causes of Action; a fined of \$2,000.00 for each of the Third, Sixth, Tenth, Thirteenth, Seventeenth, Eighteenth, Twenty-First, Twenty-Fourth, Twenty-Seventh, Thirty-Third, Thirty-Sixth and Thirty-Ninth Causes of Action; a fine of \$10,000.00 for each of the Eighth, Ninth, Eleventh, Twelfth, Fourteenth, Fifteenth, Sixteenth, Nineteenth, Twentieth, Twenty-Eighth and Twenty-Ninth Causes of Action; and a fine of \$500.00 for the Fortieth Cause of Action for total fines of \$202,500.00. Investigative costs and restitution were not ordered due to Respondent Home Masters' Chapter 7 bankruptcy filing. License numbers 32797, 32799, 32801, 46308 and 73315A, Home Masters were revoked. License numbers 82380 and 82469 shall remain suspended for a period of thirty (30) days. If within thirty (30) days, Service Masters, Inc. demonstrates to the Board that Morton Maxwell Winer has been removed as an officer, director, qualifier, associate or partner of Service Masters, Inc., the suspension shall be lifted. If the licenses are still suspended at the end of thirty (30) days, the licenses shall be revoked. This matter shall be forwarded to the District Attorney's office for prosecution for diversion of money as specified in NRS 624.750(4), and (5)(b), and/or other violations as the District Attorney's office determines to be appropriate.

4. DISCIPLINARY HEARING: DEFAULT ORDERS

a. AWESOME FLOORS, INC., License Nos. 71939, 59488

Licensee was present but not represented by counsel at the hearing.
