There are no appearances by Respondent or Homeowners; Prosecutor Jack Juan, Esq.; Terry Wike, Compliance Supervisor. ALJ Richard Scotti, (ALJ) asks whether an Answer was received on this instant case and finds that Respondent is in Default due to Respondent not filing an Answer, requesting an extension or making an appearance today. The ALJ then incorporates all of the information from the Notice of Hearing and moves to the disciplinary prima facie case. The Prosecutor is able to provide due process through certificate of service at last known address.
