- Received 436 new license applications and 456 change applications;
- Issued 216 new licenses;
- Approved 1195 license renewal applications;
- Renewed and issued 53 Certificates of Eligibility to receive preference in bidding; and
- Hosted 2 online Business Assistance Program with 17 participants in attendance.

Investigations Department:

- Held Disciplinary Hearings where 34 cases were heard;
- Opened 23 Recovery Fund claims and held one Recovery Fund meeting where 5 claims were considered and 5 were awarded a total of \$60,793,40.

Compliance Statistics:

- During the months of November and December, Compliance received 248 complaints and closed 320 complaints
- 956 compliance cases open with the average days of 177 days open
- 17 cases are currently pending discipline.
- 40 Citations were issued along with 85 suspensions
- Average number of days pending discipline were 17 days, plus 30-days notice of requirements;

Criminal Statistics:

- During the months of November and December, the Criminal department received 116 complaints and closed 103 complaints
- 361 Criminal Cases open, less than 90 days open
- 39 Administrative Citations were issued;
- No Bench Warrants were reported; however, 6 criminal cases were sent to the District Attorney's Office between November 1st and December 31st of 2023, and
- There are currently 12 Court Cases Pending Adjudication.
