Respondent is not in attendance. Appearances are made in person by Joe Kraus and Ann Church for Nevada Paving; Prosecutor Jack Juan, Esq.; Terry Wike, Compliance Supervisor. After proving up the default, the Administrative Law Judge (ALJ) finds sufficient evidence through facts and circumstances for a default. Joe Kraus gives sworn testimony that he will file a claim for \$18,433 against the bond. The Board recommends that the license be revoked and that Respondent be found to be in violation of allegations #1 through 5 with fines of \$1,000 per each allegation. The Administrative Law Judge (ALJ) **ORDERS that the license is revoked immediately.** Further **ORDERS** that Respondent is found to be in violation of Allegation #1 with a fine of \$1,000; in violation of Allegation #2 with a fine of \$1,000; in violation of Allegation #3 with a fine of \$1,000; in violation of Allegation #4 with a fine of \$1,000; in violation of Allegation #5 with a fine of \$1,000, for a total of \$5,000. That fees and costs will be assessed and are to be paid within thirty (30) days of the date of the Decision and Order.
