Taylor, partners, license number 43684 guilty of violation of NRS 624.3011(1)(b)(1) willful disregard and violation of the building laws of the State or of any political subdivision thereof; NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; NRS 624.302(6) failure to comply with a written request from the Board for information or records; NRS 624.3013(3) failure to establish financial responsibility. Mr. Jon Taylor and Mrs. Lisa M. Taylor were assessed a fine of \$500.00 for the Third, Fourth and Fifth Causes of Action for a total fine of \$1,500.00. The First and Second Causes of Action were dismissed. Investigative costs were assessed in the amount of \$2,739.00. Fines and costs are to be paid within 60 days from July 20, 2005 or license number 43684, T N T Roofing will automatically be Suspended. The monetary license limit for T N T Roofing, license number 43684 was reduced to \$225,000.00.

License number 55805, B M B Electric, LLC is Revoked. Mr. Bixman was assessed a fine of \$500.00 for the First, Second and Third Causes of Action for a total fine of \$1,500.00. James Everson is not permitted to act as the Qualified Employee for any entity in the State of Nevada for Two (2) years. Hearing Officer Scroggins found Respondent Louis Carey Foster, dba Louis Foster, license number 54969 guilty of violation of NRS 624.3017(1) substandard workmanship; NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with the Board's Notice to Correct; Two (2) violations of NRS 624.301(4) failure to prosecute a construction project with reasonable diligence, thereby causing material injury to another; Two (2) violations of NRS 624.301(5) failure to comply with the terms of a construction contract or written warranty, thereby causing material injury to another; Two (2) violations of NRS 624.3011(1)(b)(1) willful disregard of the building laws of the State or of any political subdivision thereof; Two (2) violations of Two (2) violations of NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; NRS 624.3013(3) failure to establish financial responsibility; Three (3) violations of NRS 624.302(6) failure to comply with a written request from the Board for information or records; NRS 624.3013(5), as set forth in NAC 624.640(3) failure to notify the Board of change of address or personnel within 30 days after the change occurs; NRS 624.301(1) abandonment without legal excuse of any construction project engaged in or undertaken by the licensee as a contractor; NRS 624.301(2) abandonment of a construction project when the percentage of the project completed is less that the percentage of the total price of the contract is paid; NRS 624.302(5) failure to cooperate in an investigation; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license. Mr. Foster was assessed a fine of \$2,000.00 for all Causes of Action. The Twentieth Cause of Action was dismissed. Investigative costs were assessed in the amount of \$2,810.00. Fines and costs are to be paid within 120 days from July 20, 2005 or license number 54969, Louis Foster will automatically be Suspended. Mr. Foster was ordered to pay restitution to Robyne Brooks in the amount of \$45,000.00. A Promissory Note and Deed of Trust must be to Robyne Brooks within 2 weeks from July 20, 2005 and paid within 6 months or license number 54969, Louis Foster will automatically be Suspended. Mr. Foster was ordered to complete the Luu project within 3 weeks after Brooks receives the Certificate of Occupancy or license number 54969, Louis Foster will automatically be Suspended. Mr. Foster was ordered to furnish a financial statement prepared by a Certified Public Accountant within 30 days from July 20, 2005 or license number 54969, Louis Foster will automatically be Suspended.

The Respondent is ordered to submit to a Business Review. The result of the Business Review will be presented to the Executive Officer. The Respondent will be provided a billing and will reimburse the Board for the cost of the Business Review within 10 days of receipt of the billing. Failure to submit to the Business Review or reimburse the Board the investigative cost will result in the Suspension of the license.
