Ms. Grein called the hearing to order and explained the purpose of the hearing is to received public comment on the proposed regulation to amend Chapter 624 of the Nevada Administrative Code to establish the requirements for granting an exemption to an owner of property pursuant to NRS 624.031(4). She indicated that the notice of the hearing had been posted in compliance with NRS 233B at the Las Vegas City Hall, the Sawyer State Building, Clark County Library, Washoe County Courthouse, Washoe County Library, Reno City Hall and the offices of the State Contractors Board in Reno and Henderson.

Ms. Grein indicated that there had been no opposition or comments received at the workshop conducted prior to this hearing; no written comments had been received and that the regulation as written would be placed before the Board for adoption as a temporary regulation at its next Board meeting scheduled for November 20, 2002.

Ms. Leighton requested clarification whether an affidavit would require Nevada State Contractors Board approval and what type of projects would require the affidavit. Ms. Grein indicated that presentation of the form approved by the Contractors Board would be the only approval required and further advised that any project that requires a building permit would require the signed affidavit.
