BOARD TAKES DISCIPLINARY ACTION AGAINST TWELVE LICENSED CONTRACTORS

(*Henderson, NV*) – At its meeting on July 22, 2003, the Nevada State Contractors Board adjudicated cases against twelve (12) licensed contractors.

Summary Suspension

Visionscapes, license number 42780 (Landscape Contracting) based out of Las Vegas, Nevada was summarily suspended by the Nevada State Contractors Board.

The Board acted under a provision of the Nevada revised Statutes (NRS) 624.291, which gives the Board authority to suspend the license of a contractor without a hearing if the board finds, based upon evidence in its possession, that the public health, safety or welfare imperatively requires summary suspension of the license.

S&S Landscaping Inc, license numbers 30099A (Landscape Contracting), 39326A (Concrete Pouring), 39327A (Masonry) and **S&S Landscape**, license number 44717 (Awnings) based out of North Las Vegas, Nevada were found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; abandonment of a construction project; willful disregard of building laws; failure to provide required disclosures; failure to include license number and monetary limit on a contract or proposal and bidding to contract in excess of established license limit. A permanent letter of reprimand was placed in licensee's file; licensee was fined \$4,000 and assessed the cost of investigation.

Mesa Mechanical Inc., license number 10339A (Plumbing & Heating) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for acting in the capacity of a contractor beyond the scope of the license. A permanent letter of reprimand was placed in licensee's file.

Mark Anthony Perry dba Perry's Concrete, license number 43449 (Concrete Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to establish financial responsibility; bidding to contract beyond the established license limit; failure to obtain the required lien releases; failure to include license number and monetary limit on a contract or proposal; failure to keep in force a bond or cash deposit and failure to cooperate in the investigation of a complaint. The Board revoked the license of Mark Anthony Perry dba Perry's Concrete.

Encompass Electrical Technologies of Nevada Inc., license number 51697(Electrical Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for misuse of a license;

lending of a license; combining with an unlicensed person; illegal transfer of a license and failure to establish financial responsibility. The Board revoked the license of Encompass Electrical Technologies of Nevada Inc.

Robert Wayne Kuhn dba A Acoolco, license number 39939 (Refrigeration and Air Conditioning) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; willful disregard and violation of building laws; failure to cooperate in the investigation of a complaint; failure to provide required disclosures; and failure to keep in force a bond or cash deposit. The Board revoked the license of Robert Wayne Kuhn dba A Acoolco.

Quannah Concrete Inc., license number 42537 (Concrete Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; failure to cooperate in the investigation of a complaint; failure to keep in force a bond or cash deposit and failure to report to the Board a change of address or personnel. The Board revoked the license of Quannah Concrete Inc.

Empire Roofing, license number 33573 (Roofing) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to establish financial responsibility; failure to obtain required lien releases; failure to cooperate in the investigation of a complaint; failure to report to the Board a change of address or personnel and failure to keep in force a bond or cash deposit. The Board revoked the license of Empire Roofing.

Natashi West Inc., license number 43885 (Finishing Floors) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to establish financial responsibility; failure to report to the Board a change of address or personnel; failure to keep in force a bond or cash deposit and failure to cooperate in the investigation of a complaint. The Board revoked the license of Natashi West Inc.

Aron Investments, LLC dba Designer Carpet & Flooring, license numbers 46006 (Tiling), 46007 (Install Terazzo & Marble) and 46008 (Finishing Floors) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to comply with a notice to correct; substandard workmanship; failure to include license number and monetary limit on a contract or proposal; failure to provide required disclosures; failure to establish financial responsibility; failure to keep in force a bond or cash deposit; failure to cooperate in the investigation of a complaint and failure to report to the Board a change of address or personnel. The Board revoked the licenses of Aron Investments, LLC dba Designer Carpet & Flooring.

Blue Design, license number 50827 (Residential and Small Commercial) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for contracting in excess of established license limit; combining with an unlicensed person to perform unauthorized acts and failure to ascertain the license status of each person considered for bidding. A one-year letter of reprimand was placed in licensee's file; licensee was fined \$1750 and assessed the cost of investigation.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.
