#### CONTRACTORS BOARD TAKES ACTION ON SIX CASES DURING NOVEMBER 2022 DISCIPLINARY HEARINGS

LAS VEGAS and RENO, NEV. – The Nevada State Contractors Board took disciplinary action against six licensed contractors for violations of Nevada Revised Statutes Chapter 624 including revoking two licenses and suspending one other during its November hearings. All Board hearings were conducted in compliance with Nevada Open Meeting Law requirements.

The Respondent was also ordered to reimburse the Recovery Fund for any monies paid out to the Complainant.
