## CONTRACTORS BOARD CRIMINAL CITATIONS IN NOVEMBER RESULT IN \$69,000 CONSUMER RESTITUTION

(Southern Nevada)

During the month of November, the Nevada State Contractors Board investigated 75 complaints of unlicensed contractors in Southern Nevada. Charges of contracting without a license have been filed against 48 individuals. As a result of the investigations, **\$68,906** in restitution to consumers was ordered in November 2002.
